quadrangle maps, the NCSS on-line Mobile County, AL soil survey maps and data with color aerial photography, USFWS National Wetlands Inventory maps, FEMA FIRM maps, and 13 March 2009 field review of the dirt pit/proposed construction & demolition landfill and the surrounding area; the 1,320 linear feet of drainage ditch and approximately 0.08 acre of wetlands identified on the site by the project consultant are entirely man-induced features that have established in upland/non-hydric soils as a direct result of the dirt pit operation that has been conducted on the site for many years. The dirt pit operation, which is surrounded by developed single-family residential lots and roadways, has resulted in excavation of upland/non-hydric material from the review area to an elevation that ranges from 20 to 40 feet lower than the surrounding properties. The man-made drainage ditch and man-induced wetland area are features that were created within upland soils in the dirt pit to re-direct and collect stormwater within the pit to facilitate the removal of aggregate material (dirt/sand/clay) from active mining areas. The man-induced ditch and stormwater wetland are entirely contained within the pit and do not have any natural or man-made mechanism to discharge surface water from the review area to nearby streams or wetlands associated with Rabbit Creek.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
