Summarize rationale supporting conclusion that wetland is "adjacent": The wetlands delineated along the margins of the upland project site drain directly to Chickasaw Creek which is identified on a list of Section 10 Waters of the Mobile District within the State of Alabama. Inundation and soil saturation within these wetlands adjacent to Chickasaw Creek are subject to the effects of regular tidal fluctuations that occur in Chickasaw Creek. These wetlands are also located within the 100 year floodplain along Chickasaw Creek which also makes them subject to storm surge from hurricanes and other weather events that cause high water and flooding.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project review area for the proposed Viaduct road re-surfacing and limited surface widening activities is limited to uplands within the existing road footprint and within the existing road right-of-way. There are jurisdictional wetlands as delineated and flagged in the field by Barry A. Vittor & Associates and shown on the project drawings provided by Asarisi and Associates, which are adjacent to the project alignment; however the project as proposed will not impact these wetland areas.
