#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Explain: Stream appears to be maintaining natural channel morphology features including run/riffle/pool complexes and has good woody structure for instream habitat and natural maintenance of stream pattern, profile and dimension. Expected number and distribution of run/riffle/pool complexes per river mile of this stream is not known.

Explain findings: The tributary helps convey organic carbon and nutrients from decaying riparian plant material and woody debris downstream to the resident amphibians and aquatic invertebrates, and aquatic and terrestrial vertebrates spawning, foraging, seeking shelter from predators, and/or residing permanently in Rock Creek and its adjacent riparian lands. Evidence of utilization of the area by deer, rabbits, and raccoons were observed while on-site through indicators such as recent tracks and scat.

Summarize overall biological, chemical and physical functions being performed: The wetlands proposed for impact are close to the 2<sup>nd</sup> leg of a headwater system for Rock Creek and exhibit those qualities one would expect in such system however some alterations due the urbanization have occurred. Although impairment is obvious within the watershed and the system itself, downstream of the project site, Rock Creek and it's assoicated wetlands exhibit higher quality swamp habitat. These areas can act as nutrient sinks and provide water quality treatment for removal of nitrates, phosphates, sediment and other water quality detriments from man-made activities. Removal of input from headwater areas will have an effect upon water budgets to areas located downstream of the manipulation or impoundment.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
