impact area, and the remainder of the tributary upstream of the project area has been channelized over time and modified into an urban drainage way consisting of open ditches through subdivisions and along roadsides as well as piped and culverted drainage segments. Based on review of aerial photography resources available through Google Earth and the NCSS web soil survey there is a remaining approximately 1,000 linear foot segment of the tributary downstream (north) of the project area which has a forested buffer and canopy covering the tributary channel, which suggests this last segment of the tributary prior to its convergence with Bowie River has been less disturbed and altered by human activities although this has not been field verified by USACE staff.

Explain: Photo documentation of the project area provided with the permit application information shows that the tributary banks are well vegetated with grass and other herbaceous plant species; however there are areas of rill and gully erosion in the banks and slumping of bank soils particularly around stormwater drainage outfalls and along sewer and water lines running parallel to and crossing the tributary. Photo documentation also shows that various types of rock as well as concrete and brick rubble have been placed on the banks over time in attempt to address erosion concerns.

Presence of run/riffle/pool complexes. Explain: Photo documentation provided indicates the tributary does contain glide pool complexes and riffles across existing concrete rubble in the channel.

Explain: The water flowing in the tributary shown in photo documentation is clear with no turbidity, however there is extensive filamentous green algae growth in the channel below the water line and along the margins of the water in the channel.

Identify specific pollutants, if known: No specific pollutants to this tributary have been identified through the 303(d) listing process, however due to its location within an urban commercial and residential setting, there is high potential for the introduction of petroleum and hydrocarbon compounds from automobiles and roadway runoff, fertilizers, pesticides and herbicides in runoff from lawns and landscaped areas and utility line rights of way, and potential for sewage overflows to the tributary as a result of the public sanitary sewer line and man holes located parallel to and crossing the tributary .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
