- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The JD review site is an approximately 0.09 acre portion of a larger roughly 0.89 acre wetland depression that is connected to a second approximately 0.3 acre offsite wetland depression approximately 650 feet to the southeast by an 89 foot long ditch excavated through a fallow agricultural field; however, the second wetland depression to which the JD review site is connected has no observable surface water conveyance feature or channel that connects these wetland features to Clear Creek (the nearest jurisdictional RPW) which is approximately 4,100 linear feet to the southeast (see attached maps and aerial photographs). On 29 June 2010 random soil cores observed (using approx. 1-inch diameter soil probe) in the fallow agriculture field area between the two (2) wetland depressions and along the margin of the connecting ditch found disturbed, mixed loamy sand soils from years of agricultural activity which had no hydric soil indicators or evidence of wetland hydrology. The soil at the southeast down gradient end of the second 0.3 acre wetland depression was too tightly compacted from years of agriculture activity to obtain a soil core for observation below the top inch or two of soil material. The NRCS soil map accompanying this document classifies the soils surrounding the JD review area wetland and the second wetland depression to which it is connected as somewhat excessively drained upland soils of the Troup loamy sand 0-5% slope soil unit. As a result of this lack of a hydrologic connection to downstream waters of the U.S. and wetlands, the wetlands in the JD review site are isolated and non-jurisdictional (see attached agent's JD report letter).**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

conveyance feature or channel that connects these wetland features to Clear Creek (the nearest jurisdictional RPW) which is approximately 4,100 linear feet to the southeast (see attached maps and aerial photographs).

Wetland area has no observable channels or surface conveyances that provide connectivity between this wetland depression and the nearest jurisdictional Section 404 waterway (Clear Creek, its tributaries and abutting wetlands) that is located approximately 4,100 linear feet southeast of the JD site wetland.**
