- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The +/-0.04 acre isolated wetland depression is a remnant wetland pocket that has developed in a low area south of the embankment of a former pond that existed on the property. The historic pond feature, which is shown on the 1986 Walker Springs, AL USGS topographic quad map, had clearly been filled in with upland soil by 1992 based on January 20, 1992 aerial photographic information. On the ground inspection reveals that the wetland pocket is entirely surrounded by upland soils which exhibit none of the soil, hydrology, or vegetation indicators required for an area to be classified as jurisdictional wetland, nor does a defined bed and bank stream channel, surface water conveyance swale or wetland drain exist to provide a surface hydrology connection between the wetland pocket and other wetlands on the property that are adjacent to and located within the Bassett Creek floodplain. The NRCS soil mapping of this site classifies the soil in and surrounding the depression as an upland soil type, Cahaba fine sandy loam 0-2% slopes that may be occasionally flooded and can also contain up to 3% hydric soil inclusions particularly in and near floodplains or along stream terraces.**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This wetland is an isolated depression that appears to be a remnant feature that was left behind when a pond that previously existed on the property was filled in prior to 1992. The wetland pocket is non-jurisdictional under the "SWANCC" decision. It has no surface water connection to any jurisdictional wetland or waterbody. There is no discrete or confined conveyance of stormwater or other surface water flow that connects the depressional wetland to any other wetland or water of the United States, therefore, the wetland has no significant nexus to other wetlands or waters of the U.S.
