- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The +/-0.10 acre isolated water is a man-made pond excavated in an upland hillside on the property. This pond was constructed to support the historical agricultural, silvicultural, and livestock grazing uses of the property. On the ground inspection revealed that the pond is entirely surrounded by upland soils which exhibit none of the soil, hydrology or vegetative indicators required for an area to be classified as jurisdictional wetland although the pond does exhibit physical indicators (bent vegetation) that water will at times overflow out of the pond across a section of the berm during storm events. There is no defined bed and bank stream channel, surface water conveyance swale or wetland drain providing or maintaining a surface hydrology connection between the pond and the wetland drains and waters off the property to the north property that flow to a tributary to Okatoma Creek. There is a minimal emergent fringe of wetland vegetation on a highly variable 2 to 6 foot wide shelf along the water line on the interior of the pond berm. The NRCS soil mapping of this site classifies the soil surrounding this specific pond as dominated by the Smithdale fine sandy loam 8 to 15% slope and Savannah loam 5 to 8 % slope partially hydric soil types.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The water being considered is an isolated man-made (excavated and bermed) pond constructed in uplands. The pond appears to be a water feature that was constructed in the side of an upland hill at a time when the property was being used for a combination of agricultural, silvicultural, and livestock grazing purposes. The pond is non-jurisdictional under both the "SWANCC" and "Rapanos" decisions. It has no surface water connection to any jurisdictional wetland or waterbody. There is no discrete or confined conveyance of stormwater or other surface water flow that connects the pond to any other water of the United States or wetland, therefore; the pond has no significant nexus to other wetlands or waters of the U.S.
