CWM REMOVAL PROJECT COMPLETED:

Environmental cleanup continues at Dunn Field

With the chemical warfare materiel (CWM) removal project now completed, the Memphis Depot environmental team is moving forward with the next steps to restore Dunn Field for productive reuse.

Depot staff and contractors involved in the CWM cleanup highlighted the final steps of the project at an open house for the media in May. Their presentation, which was also given at the May Restoration Advisory Board (RAB) meeting, also focused on other activities that are now taking place to complete the investigation and cleanup of the soil and groundwater on Dunn Field.

During the presentation, Clyde Hunt, the Depot's Remedial Project Manager, described the CWM Transportation and Disposal Plan for all excavated soils and materials that was approved by the Base Realignment and Closure (BRAC) Cleanup Team (BCT). Based on this plan, all CWM-related materials were removed from the site to approved waste management facilities outside the state of Tennessee. The BCT includes representatives from the Environmental Protection Agency (EPA) and the Tennessee Department of Environment and Conservation (TDEC).

"We're already moving forward with the next phases of the environmental cleanup at Dunn Field, as required under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA)," said Hunt. "According to CERCLA, each phase must be completed and approved by the BCT before the next phase can begin. This is the same process we followed for the cleanup of the Main Installation."

• The Remedial Investigation (RI) will provide the BCT with an in-depth scientific analysis of the environmental conditions at Dunn Field and the potential risks to human health and the environment. This information will be used by the BCT to identify areas on Dunn Field that require cleanup. The RI is scheduled for completion in the fall of 2001 and will be placed in the Depot's Information Repositories (IR) for public review.

- The Feasibility Study (FS) will evaluate different cleanup alternatives for soil and groundwater at Dunn Field and will also evaluate if alternatives will be protective of human health and the environment. The FS is scheduled for completion in the winter of 2001, and the completed report will be placed in the IRs for review.
- The Proposed Plan (PP) for Dunn Field will present the BCT's
 preferred cleanup alternatives for soil and groundwater at Dunn
 Field. The PP is scheduled for completion in the spring of 2002.
 The completed report will be placed in the IRs for review, and a
 public comment period will be scheduled.
- The next phase is the Record of Decision (ROD) for Dunn Field, which documents the public's comments on the PP and the selected cleanup alternatives. The ROD is scheduled for completion in the summer of 2002.

Once the ROD is signed by the Environmental Protection Agency, the final CERCLA phases will begin. The final phases are the Remedial Design, which details how the selected cleanup alternatives will be applied, and the Remedial Action, which includes construction and performance of the selected cleanup alternatives.

Second Finding of Suitability to Transfer (FOST) Completed

Parcel of Depot property available for transfer to the City

The Memphis Depot has reached another important milestone in the reuse of the Main Installation (MI), now known as the Memphis Depot Business Park.


The Defense Logistics Agency (DLA) and the Department of the Army held a 30-day public comment period from June 1 to June 30, 2001, for its second Finding of Suitability to Transfer (FOST). This report is part of the Base Realignment and Closure Act (BRAC) process and is required to transfer the ownership of Depot property to the City of Memphis for community redevelopment.

The first FOST, a 6.5-acre area known as the family housing area, was finalized last year. FOST 2 includes 15.55 acres of the MI. The area includes seven buildings, the open land area and the two paved parking lots surrounding the Administration Building (Building 144). A FOST report includes a detailed investigation of the historic uses of the area, as well as any environmental issues and cleanup remedies that may have been required. FOST 2 concludes that the former administrative areas are suitable for transfer to the City in accordance with the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA).

"This is a significant milestone for the Depot," said Clyde Hunt, Remedial Project Manager at the Depot. "The transfer of this parcel of land to the Depot Redevelopment Corporation will allow the Memphis Police Department to build a new Southeast Precinct on the property. A positive impact for our community."

The Environmental Protection Agency (EPA) and the Tennessee Department of Environment and Conservation (TDEC) reviewed FOST 2. The report was then placed in the Depot's four Information Repositories, and the public was invited to review it and comment. Once public comments have been incorporated, the final FOST 2 report will be sent to the Army Materiel Command for approval and signature.
