SUBJECT: Defense Distribution Depot Memphis, Draft Final, Interim  
Holding Facility Plan

1. References:

Distribution Depot Memphis, Draft Interim Holding Facility Plan.

2. We have reviewed the subject document and have the following  
comments:

a. In our previous comments (ref 1b), we noted that there is  
no information provided on the length of storage of CWM in the  
holding facility. This concern has not been addressed. An  
approximate period of storage should be included to allow the  
installation to determine when that area will be available for  
reuse.

b. Since the material is being regulated under RCRA, it seems  
that a permit would be required for the use of the facility. If  
so, the organization responsible for obtaining the permit and  
generating the closure report should be identified.

c. If there is a possibility of the parcel containing the  
bunkers being transferred prior to the investigation of Dunn Field,  
contingency plans for the interim storage of the material should be  
prepared.
