Two comments.

1. If we are "disbanding" the BCT because the BRAC process is at an end, then FY11 and beyond should call for a Site Management Plan in its place, not continuing with BCPs. We should also discuss at next meeting the scope of this document, as compared to a BCP. If DLA wants to leave it as is for the FY10 BCP that's OK with me.

2. Given the current estimates of how long it will take to achieve RAOs for the MI and Dunn Field, basically RGs for ground water, the activities related to final closeout report and site closeout should probably be pushed out in the FY11 SMP. In the PCOR I estimate 2038 for the MI FCOR and 2040 for Dunn Field. The reality may be elsewise, but 2021 seems optimistic for site closeout. Don't need to change it this year, but we should discuss for next year.
