
Dear Representative DeBerry:

I'm writing to you for assistance in our plight with the Defense Depot Memphis Tennessee because I trust you and respect you. Your political power and influence can remedy the grievous injustice being perpetrated upon the black citizens of South Memphis.

In the Defense Depot matter, the Environmental Protection Agency has failed to comply with Effluent laws that forbids the release of lead into sewers and drainage ditches. To date, EPA has made no efforts to contain EPA action—levels of lead released via open ditches into black neighborhoods, including yours Ms. Deberry.

In spirit (if not the letter of the law), Title III of SARA and EPCRA are being violated by the aforementioned parties. Regulatory agencies have kept the Toxic Release Inventory for the Defense Depot secret. Regulatory agencies governing the clean-up at the Defense Depot treat the Clean Water Act as a joke, totally disregarding it. Charts and statistics clearly indicate toxic chemicals and heavy metal elements in the surface water runoff into drainage ditches that eventually empty into Cane Creek and Nonconnah Creek, both tributaries of the Mississippi River. CWA clearly prohibits toxic lead discharges from a point source into navigable waters, such as the Mississippi River, which meander directly over the Allen Wellfield.

Every effluent standard of the City of Memphis, the County of Shelby, and the State of Tennessee and the Safe Drinking Water Act is being violated by the Defense Depot and white washed by regulatory agencies.

Along with Chris Kartman, Jeff Kellam and Jordan English should be fired. Public Relations is one thing. Coupled with subterfuge and incompetence, outright lies are another thing. The incompetent trio — Cartman, Kellam, and English — have contributed heavily in deceiving EPA, the Corp of Engineers, the commander of the

military facility, and black people attending public meetings. Water under Artesian conditions can't flow upward; toxic water in contaminated ditches don't have a pathway to contact people, contaminated water can't evaporate; lead particles left in a dry ditch can't be wind-blown out of there is no water in an aquifer—all of these lies were told at a meeting by the incompetent trio! Is Jeff Kellam a Ph. D geologistion a fool? What about English and Kartman?

But, these things are minor when compared to the "Plume Theory," the generic, pat used-over-a-thousand-times explanation CHZM Hill uses at federal facilities around the country. It has nothing to do with Memphis, the Defense Depot, or the contamination of the Fluyial Aquifer. The plume theory is crazy. It claims that contamination from burials have magically descended to the watertable without leaving a trace of contamination in its pathway and its source. Magically, the plume is well-defined and perfect for CH2M Hill's "pump and treat" method of remediation. Kellam should be fired. He ignored the professional and very well-respected work of Parks, William S., 1990, Hydrology and Preliminary Assessment of the Potential for Contamination of the Memphis Aquifer in the Memphis Area, Tennessee. Water Resource Investigations Report 90-4092. Prepared in cooperation with the City of Memphis, Memphis Light, Gas, and Water Division. Parks' reported that there was a hole in the confining clay immediately under the Defense Depot's toxic burials that led to contamination being drawn into the Memphis Sands Aquifer and pumped into the homes of black residents in South Memphis. Being the incompetent geologist that he is, Kellam completely ignored Parks' work, very stupidly settling on the Plume Theory that is going to waste the Corp of Engineers time and waste \$6.500,000 of taxpayers' money.

Because of the violations of the laws of the United States of America enacted by congress and the incompetence of regulatory officials (who need firing), I believe it is no more than fitting and proper that I appeal to you for help in forcing all of the aforementioned parties and agencies to comply with the laws of the land.

In addition, pursuant to the Freedom of Information Act, I appeal to you Representative Deberry for help in obtaining copies of all files, records, and documents possessed by the Defense Depot Memphis Tennessee which relate to air, soil, and water pollution, hazardous waste use, storage, and disposal, and any environmental
