Meeting Minutes

BCT reviewed and signed the July meeting minutes and the August LTOA conference call minutes.

Review of Project Status

Building 949 Work Plan

Mr. Kraig Smith reported that Jacobs submitted the work plan to the BCT on August 4, 2001. The BCT discussed with Jacobs their comments on the work plan. Disposal characterization sample results indicated waste soil must be disposed as a hazardous waste due to chromium levels. The BCT suggested that confirmation samples include analysis for chromium and that waste disposal characterization must comply with the requirements of the state accepting the waste.

The BCT discussed and agreed on a cleanup level of 450 ppm for chromium based on the Region 9 Preliminary Remediation Goals. Mr. Turpin Ballard will document the rationale for the chromium cleanup level and provide to Mr. James Morrison.

Jacobs intends to begin the remedial action on August 27, 2001

Dunn Road RR Track Removal

S&W Asphalt received the notice to proceed the week of August 6, 2001. Mr John Rollyson anticipates work will begin the week of August 27, 2001

Main Installation LTOA Wells

Mr Rollyson anticipates providing Jacobs the notice to proceed by August 24, 2001, and that work will begin in the third week of September. Mr. Smith indicated he had scheduled with the rotosonic drillers. Mr. Steve Offner will provide the work plan addendum early the week of August 27.

Mr. Ballard requested a well installation scheduled as soon as possible in order to schedule travel. Mr. Smith anticipated starting the rotosonic drilling the second week of October. Mr. Smith will provide the well installation schedule for the rotosonic drilling at the September BCT meeting.

Dunn Field Remedial Investigation

Mr Offner reported he was on schedule to provide Revision 0 on August 24. He briefed the BCT about a very clear fingerprint of unique VOC moving southwest from off site (upgradient) and co-mingling with VOCs from Dunn Field. While Mr. Offner indicated monitoring well results provided a clear plume boundary, he suggested installing an additional monitoring well and a soil boring during the design or operations and maintenance phase to provide greater confidence in the plume boundary between MW40 and MW42 and the lithology between MW40 and MW79.

Mr. De Back discussed the impact of the off site, upgradient plume on future property transfer

Dunn Field SVE Treatability Study

Mr Ballard questioned the schedule presented in the Restoration Advisory Board briefing, and Mr. Offner pushed the dates back by one month due to anticipated contracting issues. If the loess results indicate the need to enhance the SVE system, the feasibility study will evaluate the enhancements.

Land Use Control Assurance Plan/Land Use Control Implementation Plan

Mr. Ballard reported the ROD has completed the inter-service review, and EPA is preparing a written response to the latest LUCAP revision submitted by the Army.

Finding of Suitability to Transfer #3

Mr. De Back discussed delineating areas that could be included in the next FOST. Mr. Ballard indicated the LTOA data would provide a better picture of the areas suitable for transfer once land use controls are in place. Mr. De Back requested that Mr. Ballard and Mr. Morrison provide input as to the areas that could be included in the next FOST.

Document Review using Adobe Acrobat

Mr. Offner provided instructions for accessing the Depot's documents on CH2M HILL's server. Mr. Ballard provided instructions for using the system to review and comment on documents Mr. De Back requested that CH2M HILL designate comment colors for each securing the document so that comments cannot be deleted. The BCT instructed Mr Offner to establish security protocols for each document. The BCT discussed how to comment in order to facilitate the response to comment procedure.
