It is important to note that the Record of Decision and any required subsequent steps like remedial design and remedial actions have not changed. Also please note that CH2M Hill has requested what amounts to an additional week as the enclosed letter explains.

Also find enclosed a schedule change that was requested/recommended by the Corps of Engineers on the Dunn Field Remedial Investigation in June 1999. This was discussed at the June BCT. Again, the BCT discussed how this schedule change moved out some interim steps but didn't effect the final Record of Decision date. The schedule change was prompted by a desire to include the recent offsite monitoring well data into the groundwater portion of the Dunn field Remedial Investigation.

Both these proposed schedule changes will be incorporated into the overall project schedule through the use of the project GANTT chart. This will be handed out at the August BCT meeting. 

SUBJECT: Adjustment to the Schedule of Reports for the Remedial Investigation/Feasibility Study at Dunn Field, Defense Depot Memphis, TN

- A schedule adjustment for the subject work is requested. table comparing the current verses the new requested Dunn Field schedule is at Encl 1.
- This schedule extension is requested for the following reasons:
- Notice to proceed for installing a well on Mr. Ronald Belz property is anticipated by early to mid June 1999. The data that will be gathered from the Belz Well should be incorporated into characterization and risk conclusions in order to address all potential impacts. The current submittal date of 9 August 1999 for the Dunn Field RI does not provide adequate time for obtaining the groundwater data and incorporating it into the Dunn Field groundwater analysis. Geologic and chemical data from this well is important in establishing the groundwater conceptual model.
- b. Public comment periods for Main Installation and Dunn Field will be sequential. Per the current schedule, the sixty day Public Review Period for the Proposed Plan for the Main Installation and Dunn Field occur simultaneously. Revising the Dunn Field schedule will cause the Public Comment period for Dunn Field Proposed Plan to begin immediately after the end of Public Comment period for Main Installation Proposed Plan.
- Revising the Dunn Field Schedule will not impact on the date of the Final ROD.
