The Alabama Department of Environmental Management (ADEM or the Department) and the Environmental Protection Agency (EPA) have reviewed Fort McClellan's submittal of the *Final Site Investigation Report for Impact Area, Parcel 136Q-X*.

Selenium and six pesticides (4,4'-DDE; 4,4'-DDT; alpha-BHC; beta-BHC; gamma-BHC and dieldrin) all exceeded ecological screening values (ESVs) in surface soil. However, based on the relatively low level of exceedences, infrequency of detection and limited extent of contaminated area, ADEM agrees that these constituents pose no significant threat to ecological receptors at this site. Therefore, the Department concurs with Fort McClellan's recommendation that Parcel 136Q-X be designated as requiring no further action (NFA) and unrestricted re-use with respect to hazardous, toxic and radioactive waste (HTRW) issues.

The Department understands that Parcel 136Q-X is located in the Charlie Area at Fort McClellan. At this time UXO matters remain unresolved at this parcel and will be addressed during ADEM's review of the Charlie Area EE/CA workplans and reports.

Dear Mr. Levy:

The Alabama Department of Environmental Management (ADEM or the Department) and the Environmental Protection Agency (EPA) have reviewed Fort McClellan's submittal of the *Site Investigation (SI) Report for the Impact Area, Parcel 136Q-X*. ADEM has the following comment.

Based on Fort McClellan's analytical data, the Department agrees that the limited number of exceedences of various contaminant levels in site media are of insufficient magnitude to pose a potential threat to human and ecological receptors at Parcel 136Q-X. Selenium exceeded its background concentration in four samples, however, the detected levels were in the same order of magnitude as the background concentration level. Selenium is a non-carcinogenic and at these levels is not considered to be a health threat to human or ecological receptors

The Department concurs with Fort McClellan's recommendation that Parcel 136Q-X be designated as No Further Action and unrestricted reuse.
