Dear Mr. Scott:

The Alabama Department of Environmental Management (ADEM or the Department) has reviewed the McClellan Development Authority's (MDA) *Final, Revision 1, Corrective Measures Implementation Report (CMIR), Impact Area, North-Central Main Post, Parcel 132Q-X and Range 31: Weapons Demonstration Range, Parcel 89Q-X and Former Defendum Field Firing Range No. 2, Parcel 215Q*, dated June 21, 2013. The Department notes that this CMIR only addresses hazardous, toxic, and radioactive waste (HTRW) issues (bullet removal) at these three parcels. All other munitions of explosive concern and unexploded ordnance related issues associated with these parcels will be addressed in the after action reports for Munitions Response Sites 12 and 13. However, ADEM's comments related to HTRW issues have been adequately addressed and the hazardous waste manifest for the disposal of bullets removed from the site has been received; therefore, the Department concurs with the Final CMIR.

The Department notes that MDA requested to move these three parcels to **Table III.2., List of SWMUs and AOCs requiring no further action (NFA) at this time** in the *Cleanup Agreement (CA)* between ADEM and the MDA for HTRW concerns. ADEM agrees with this request, and the changes should be included in the current CA modification. Please note that "HTRW" should be indicated in the "NFA Issues" column of **Table III.2.** for each of these parcels.
