Subject: Monitoring Well Abandonment

Former Fort McClellan Anniston, Alabama

Dear Mr. Cobb,

Matrix Environmental Services, LLC (MES), on behalf of the McClellan Development Authority (MDA), is requesting permission from the Department to abandon several groundwater monitoring wells at the former Fort McClellan, specifically at the Baby Bains Gap Road Ranges (BBGRR). The monitoring wells are located at Range 23 (Parcel 79Q), Range 25(Parcels 83Q and 118Q-X), Ranges South of 25(Parcels 224Q and 226Q), and Range 26(Parcel 84Q-X). These monitoring wells were installed during the investigative process of the former training areas, to determine if groundwater contamination was an area of concern. The investigative phase has been completed at all of these parcels. Furthermore, Phase I of the BBGRR remediation has been completed and the remediation of the Phase II parcels has been approved and is underway. The areas of contamination at these parcels has been determined to be surface and shallow subsurface soils only, therefore these monitoring wells will no longer be required.

MES is requesting permission to abandon these monitoring wells (see table below) in accordance with Alabama Department of Environmental Management (ADEM) Admin. Code R. 335-14. MES intention is to abandon the wells listed below before the remediation of Phase II is completed. MES will provide the Department a written notice, including the well abandonment logs, within 30 days of the completion of abandonment activities.
