

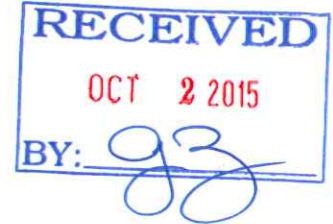

The Alabama Department of Environmental Management (ADEM or the Department) has reviewed the McClellan Development Authority's (MDA) *Remedy Selection Update/Addendum to the Final Corrective Measures Implementation Plan (CMIP) Training Area T-6 (Naylor Field), Parcel 183(6) and Cane Creek Training Area, Parcel 510(7)*. The Final CMIP for Training Area T-6 provides a treatment train that illustrates the corrective measures technologies appropriate for this site. The subject CMIP addendum documents the change in remedy from soil vapor extraction/air sparging to in-situ bioremediation. All of these technologies are included in the treatment train and described in detail in the Final CMIP. ADEM concurs with the change in remedy and with the Addendum to the Final CMIP.
