The Alabama Department of Environmental Management (ADEM or the Department) has completed its review of McClellan Development Authority's (MDA) subject document. Based upon this review, ADEM has determined that all comments (from an ADEM letter dated August 13, 2019) have been resolved. Therefore, the Department concurs with the subject document. ADEM notes that MDA revised the subject document to reference maximum contaminant levels (MCLs) instead of risk-based target levels (RBTLs) in response to ADEM's General Comment 1. However, Appendices C and D (provided on compact disc) reference RBTLs. Please ensure that all future Chemical Laundry Corrective Measures Effectiveness Reports in their entirety reference MCLs.
