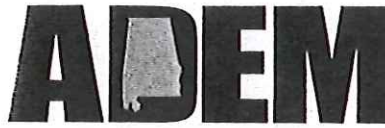

The Department concurs with the responses to comments and with MDA's recommendation to exclude analytical results for MW07 and MW09 in future Total COCs in Residuum Monitoring Well Network tables.
