The Alabama Department of Environmental Management (ADEM or the Department) has reviewed the McClellan Development Authority's (MDA) Response to ADEM Review and Comments for *Range 12: Iron Mountain Road Ranges Maintenance and Inspection Plan* (the Plan), dated May 3, 2012, as well as the *Annual Inspection of the Range 12 site, Iron Mountain Road Ranges*, dated August 10, 2012. The Department concurs that the site appears to have been reclaimed by natural vegetation and that no erosion is occurring at this time.
