The Alabama Department of Environmental Management (ADEM or the Department) has completed its review of the McClellan Development Authority's (MDA) revised *Munitions and Explosives of Concern Remediation After Action Report Munitions Response Site 2*. Clarification was provided that some procedures were documented differently for this MRS because it was one of the earliest MRSs to be cleared and standard procedures for McClellan were still evolving. Also, further information was provided on the 2013 Quad area clearance that was treated as a high density target area due to metallic interference from reinforced concrete debris and conducted using mag and dig operations. Therefore, ADEM concurs with the subject document. Please submit the environmental covenant for MRS-2 for ADEM review.
