Your request dated August 3, 2004 to continue cleanup operations at area T-38 on the former Fort McClellan property has been received and reviewed. Your request is approved based on a careful evaluation of the following information.

- None of the UXO investigative work previously conducted at T-38 was accomplished by the UXO contractor or U. S. Army Corp of Engineer unit cited in ADEM Emergency Administrative Order 04-086-EHW.
- The UXO contractor conducting the current work at T-38 is not the UXO contractor cited in ADEM Emergency Administrative Order 04-086-EHW.
- Unique equipment availability issues are involved.
- The Army has determined that the individuals that worked for the previous UXO contractor at T-38 have not been recently employed at Fort McClellan by the UXO contractor cited in ADEM Emergency Administrative Order 04-086-EHW.
- The Army has also confirmed that the current UXO contractor will be using UXO avoidance techniques at all times while in the area of T-38.

This approval only applies to the work at T-38 specified in your request. It does not apply to any other work at T-38 or to any other area.


