5	DR. MARY HARRINGTON: Would you
6	like this agenda is the agenda that we're working
7	from, unless you would like to
8	MS. DONNA FATHKE: I do believe
9	that we should
10	DR. MARY HARRINGTON: unless you
11	would like to amend the agenda, you know, add to the
12	agenda for the minutes.
13	MS. DONNA FATHKE: I would like to
14	amend the agenda to add approval of the minutes on
15	here.
16	DR. MARY HARRINGTON: Is that in the
17	form of a motion?
18	MS. DONNA FATHKE: I so move.
19	MR. PETE CONROY: Second.
20	DR. MARY HARRINGTON: It has been
21	properly motioned and seconded that the minute
22	approval be added to the agenda. Are you ready for
23	the questions? All in favor of said motion let it be

1	known	bv	I?	Opposes?

- 2 There being none, we will amend this
- 3 agenda to add the approval of the minutes. And I'm
- 4 going to make that a little dot in between the
- 5 committee report on the minute. That's where you add
- 6 it.
- 7 MS. DONNA FATHKE: Right after that
- 8 line?
- 9 DR. MARY HARRINGTON: The committee
- 10 report on the minute issue.
- 11 MS. DONNA FATHKE: At this meeting,
- 12 I expressly stated my dissatisfaction with this
- particular format of the minutes, but we left the
- 14 meeting with, this is how it's going to be at this
- 15 point. My personal feeling is that it's now on the
- shoulders of the RAB to review the transcripts and
- 17 make amendments to the minutes at each meeting so that
- 18 we can add some meat back into these minutes. Pete, I
- don't know if you want to add anything.
- 20 MR. PETE CONROY: Sure. My sense,
- 21 after having this meeting that we had the other day,
- is that this -- I'll call them sterilized minutes
- 23 right here or simplified minutes. And I think that

1	because the transcripts are provided, we really have
2	the meat that we need inside those transcripts. And
3	so, if we think that something is important, we need
4	to be more tenacious in gleaning the tone and the
5	flavor of meetings from our memories and those
6	transcripts. And then when it comes time for the
7	approval of minutes, we can add and subtract things
8	that we think are particularly important.
9	But I think, from the Army's
10	perspective, there providing this foundation on which
11	we build is adequate. But we need to work harder and
12	remember that we just don't say, yeah, approved every
13	time it comes across, because it's up to us to make
14	sure that the flavor is captured.
15	And also, recognizing the fact that
16	these minutes, essentially, sure enough they go to the
17	local libraries, and I don't know that there is any
18	long line of people waiting to read our minutes.
19	Really, the way that we communicate with the Army and
20	Washington is through the headlines of our newspaper.
21	And we need to remember that, as well.
22	MS. DONNA FATHKE: My concern with
23	adding more substance to the minutes is just that the

- 1 minutes should be an outline so if anybody wants to do
- any research on topics that have been discussed, they
- 3 can first go to the minutes, find some guidance there
- 4 on which transcripts to look at. The transcripts are
- 5 a minimum of eighty or ninety pages long. And there
- 6 is no way you could research a topic by reading
- 7 through all of that. That is my primary purpose.
- 8 MR. MONTY CLENDENIN: I have a
- 9 question. Who is taking minutes now, other than the
- 10 transcription here?
- 11 MR. GLYNN RYAN: Right here.
- 12 (Pointing.)
- 13 MR. MONTY CLENDENIN: Then there
- 14 are no minutes for this committee. If we don't have a
- 15 secretary taking minutes, minutes don't exist, it
- 16 seems to me.
- MS. DONNA FATHKE: Well, the
- 18 transcripts are taken -- and what we've done in the
- 19 past, somebody has then reviewed the transcripts and
- 20 come up with the minutes of the meeting. That
- 21 particular topic has been kind of a topic of
- discussion the last couple of RAB meetings. And we're
- 23 trying to bring it to closure.

- MR. MONTY CLENDENIN: It seems to 1
- me that it is our responsibility to provide a 2.
- 3 secretary -- we've got a chair and a co-chair -- we
- should provide a secretary. We should elect a
- secretary to take those minutes as it happens. Then
- we don't have to go back to the transcript.
- MR. PETE CONROY: That's a
- 8 reasonable option.
- 9 MR. MONTY CLENDENIN: So, I mean, I
- 10 just wonder why we're trying to put this
- responsibility on somebody else, if it's our minutes, 11
- 12 we should elect a secretary to take those minutes.
- DR. BARRY COX: Monty, I nominate 13
- 14 you as our --
- 15 MR. MONTY CLENDENIN: Now, I won't
- do it. 16
- 17 MR. RON LEVY: You've been elected,
- 18 come on.
- MR. MONTY CLENDENIN: But it seems 19
- like we're building a straw man, unless we've got 20
- 21 somebody taking minutes to respond to.
- 22 MAYOR WILLIAM KIMBROUGH: Well, my
- 23 concern is kind of like Donna's, I read the transcript

1	this	weekend.	it	took me	approximately	four	hours	to

- go through all of it. There were eighty -- there were
- 3 over eighty pages of it.
- And, you know, in the past, if I
- 5 wanted to go -- since we started getting the
- 6 transcript, if I wanted to go back, I could look at my
- 7 minutes because I don't always remember the sequence
- 8 of everything. You know, lots of the sequence is a
- 9 roll call and the introduction of everybody and all
- 10 like this. So, it helped me spot where, if I wanted
- 11 to go to a particular thing.
- 12 And so, that's basically, you
- know -- we talked about minutes. And, of course,
- 14 minutes are only supposed to show action items and
- what's voted on and all like that and in a summary.
- 16 And so, you know, our concern on the minutes thing was
- 17 at one time, a private contractor was hired by the
- 18 Army to do the minutes, which was an independent
- 19 person that was not employed by either one. And then
- they didn't renew that contract.
- 21 So then the Army assumed, you know,
- 22 taking the minutes and -- or doing the transcript,
- 23 plus the minutes. And now -- and then we did away

- 1 with the minutes. And so I guess part of the thing,
- 2 you know, was that this was part of the service. And
- 3 in the guidelines that is published by the RAB, it
- 4 says that the minutes should be -- should -- it
- 5 doesn't say should, it said could, I believe was the
- 6 term. And that was interpreted to be an option. And,
- 7 of course, then the response that we had last week was
- 8 that the Army felt like the transcript sufficed for
- 9 for that.
- 10 But in my time, I don't have four
- 11 hours or more to go over transcripts every time I want
- 12 to, you know, do that. I did it this week, to see --
- to go back and review some things. But if we just had
- 14 an index or something to just kind of show the
- 15 sequence of the activities, that's basically what the
- 16 minutes are supposed to do.
- MR. GLYNN RYAN: Let me -- Mayor,
- 18 the agenda items -- and if you look at what we
- 19 proposed is a key, if you will, an index; it tells you
- in what sequence we conducted our business.
- 21 MAYOR WILLIAM KIMBROUGH: Correct,
- 22 yeah.
- MR. GLYNN RYAN: And also, just to

1	clarify,	we,	the	Army,	did	hire	the	contractor	who
---	----------	-----	-----	-------	-----	------	-----	------------	-----

- 2 took the minutes and they did work for us, they were
- 3 not independent of either group.
- 4 MAYOR WILLIAM KIMBROUGH: Okay.
- 5 MR. GLYNN RYAN: They did work for
- 6 the Army.
- 7 MAYOR WILLIAM KIMBROUGH: But like
- 8 I say, in several meetings we've had items that have
- 9 been discussed that weren't on the agenda. But I have
- 10 no problem with this. So, if it's appropriate, since
- 11 we have amended the agenda to include minutes, then I
- 12 would like to make a motion that we approve the
- January, February, and March minutes that have been
- 14 presented tonight.
- DR. MARY HARRINGTON: That's our
- 16 next item. But they were giving me a report on the --
- 17 MAYOR WILLIAM KIMBROUGH: Okay. I'm
- 18 sorry.
- DR. MARY HARRINGTON: You know, I'm
- 20 slow tonight. I have an awful headache. But they
- 21 were giving me a report. And the next item have been
- 22 amended under that.
- So, am I correct to understand that

1	we all now are operating on, even though we're not
2	completely satisfied with what is being presented, we
3	can live with this? Is that my RAB?
4	MS. DONNA FATHKE: Well, my input,
5	again, is that if there is something that we feel is
6	important that should be in the minutes, because we
7	want it to be there as a guide mark to a further
8	discussion in the transcripts, that we should amend
9	the minutes at each meeting to reflect those items.
10	DR. MARY HARRINGTON: Well,
11	according part of parliamentary procedures will
12	always allow you to amend the agenda to include
13	certain things, and that would certainly fall under
14	them.
15	But my action is, is this
16	committee's report acceptable to RAB members that
17	we've just heard?
18	MR. SCOTT BECKETT: I've got one
19	further thing that might help. I wondered if any of
20	us feel that we're engaged in a discussion that we
21	especially want to find quickly in the transcripts, to
22	possibly amend it to the minutes, is there some way,
23	Samantha, that you can flag it in the transcript if we

- 1 ask you during the meeting, Samantha, would you,
- 2. please, flag this in bold, so that as we're scanning
- 3 the transcript, it would jump out at us?
- MS. SAMANTHA NOBLE: Yes. And I can
- 5 also make you a keyword index that will list every
- word that was said in here and it will tell you what
- page and what line it was said on, if that helps.
- 8 MR. PETE CONROY: Terrific. Let's
- 9 vote for that.
- 10 MS. SAMANTHA NOBLE: I haven't
- spoken to any of them about --11
- 12 MR. RON LEVY: The cost?
- MS. SAMANTHA NOBLE: I mean, as far 13
- 14 as I'm concerned, not printing it up on paper, if I
- just add it on the ASCI, I won't charge anything for 15
- it, so it doesn't matter to me --16
- 17 MR. RON LEVY: Hey, sounds good.
- MS. SAMANTHA NOBLE: -- I'll just 18
- put it at the end of the ASCI, if it will help 19
- everybody out. 20
- 21 MR. SCOTT BECKETT: That's a
- 22 software form --
- 23 MS. SAMANTHA NOBLE: It will be the

- 6 word, every page, every line it was said on. So, if
- 7 there is a particular keyword you're looking for, you
- 8 can go to it and go to everywhere it was found.
- Now, that's up to y'all, what y'all
- 10 want me to do, but I can do that.
- 11 MR. PETE CONROY: Let's try it.
- 12 MS. DONNA FATHKE: I so move.
- MR. SCOTT BECKETT: Second.
- DR. MARY HARRINGTON: Let me stop
- 15 y'all. You're getting away from me. I mean, I know
- 16 you so moved and you second, but that was not a
- motion. She was making a comment, a point of
- 18 information. The only thing that we can decide is
- 19 from the other RAB members, were you satisfied with
- 20 the committee's report? Can the minutes issue go to
- 21 bed?
- MR. SCOTT BECKETT: Well, as --
- DR. MARY HARRINGTON: Should we

1	accept	the	committee	' s	report	so	we	can	move	on?

- MR. RON LEVY: Somebody needs to
- 3 make a motion because that's --
- DR. MARY HARRINGTON: That's what
- 5 I'm saying, I need for somebody to make a motion so
- that we can accept the committee's report.
- 7 MR. SCOTT BECKETT: I move that we
- 8 accept the committee's report.
- 9 MR. (UNIDENTIFIED): I second it.
- 10 DR. MARY HARRINGTON: It's been
- 11 properly moved and seconded to accept the committee's
- 12 report. All in favor of staying the motion, let it be
- known by your vote and sign. I will do. Opposes, the
- same opportunity.
- Now, we can move -- and it did not
- get lost, because we put it aside, but the motion to
- accept the minutes for the last three months as
- 18 printed that you all obviously wanted to entertain, we
- 19 added to the agenda and it was motioned and seconded.
- 20 All in favor of accepting the last three months of
- 21 minutes, collectively, let it be known by --
- 22 MS. DONNA FATHKE: The motion hasn't
- been seconded, yet or open for discussion.

1	DR.	MARY	HARRINGTON:	Okay.

- 2. MAYOR WILLIAM KIMBROUGH: Somebody
- 3 seconded.
- DR. MARY HARRINGTON: It was
- seconded.
- MR. MONTY CLENDENIN: I think it was
- seconded.
- MS. DONNA FATHKE: I would like to
- 9 discuss --
- 10 DR. MARY HARRINGTON: I'm about to
- ask -- are you ready for the question? Now, is your 11
- 12 time for discussion.
- 13 MS. DONNA FATHKE: Harking back to
- 14 my previous comment, from the committee meeting, I
- have -- I did review the transcripts today, and I have 15
- six amendments that I would like to make of them. 16
- 17 Three of them are very easy, they're just taking --
- actually, for the January minutes, there was a more 18
- 19 robust minutes that was done by the Army. And the
- first three amendments that I would like to make, are 20
- just replace -- pulling three paragraphs from those 21
- 22 original minutes back into this sterilized version of
- 23 the minutes.

1	The first one you probably all
2	don't have copies of these minutes with you. But the
3	first one regards Mr. Conroy's requested clarification
4	regarding two standards of cleanup up for the refuge;
5	one standard being passive recreation with cleanup of
6	the surface to six inches and the other standard being
7	surface cleanup. Mr. Ryan replied, the Army is still
8	looking at recommendations and decisions have not been
9	made, still discussing cleanup with Fish and Wildlife.
10	I would like to insert that under
11	old business on the January 13th minutes, right after
12	the board voted on and approved amendments to the
13	bylaws.
14	DR. MARY HARRINGTON: Now, I've got
15	to have somebody help me. Our purpose for inserting
16	that is what? Because it's not an action, it's a
17	discussion.
18	MS. DONNA FATHKE: It's a summary of
19	the discussion that occurred. That particular point
20	was a point on the agenda that came up formally for
21	discussion. It was, no, not a motion or anything, but
22	it was a summary of the discussion that ensued.
23	I mean, in my point of view, a

- 1 minutes is more than just a recap of motions made,
- it's also a summary of discussions that occurred. 2.
- 3 MR. SCOTT BECKETT: It's my
- understanding of the Roberts Rules of Order says that,
- if minutes are to be provided for people who weren't
- at the meeting, that it should contain the important
- points of the discussion.
- MS. DONNA FATHKE: And that's all
- 9 I'm trying to introduce here are some points of
- 10 discussion.
- DR. MARY HARRINGTON: You made the 11
- motion. We're waiting for the second. 12
- MR. SCOTT BECKETT: Second. 13
- 14 DR. MARY HARRINGTON: Okay. Now,
- 15 do we need any discussion for that? Are you ready to

- 3 January meeting. And it reads, Mr. Ryan discussed
- 4 Mayor Kimbrough's question from the previous RAB
- 5 meeting concerning whether the fill area northwest of
- 6 Reilly Airfield was investigated in a UXO EE/CA.
- 7 Mr. Ryan provided a letter to the
- 8 Mayor and RAB members, explaining the Army's position
- 9 for investigating this area and the landfill EE/CA and
- 10 the reason for recommendation of no further action.
- 11 The Mayor expressed his concern regarding the area
- 12 being identified for active recreation and potential
- 13 risk to families.
- MR. PETE CONROY: Second.
- MR. GLYNN RYAN: Where was that
- 16 inserted?
- 17 DR. MARY HARRINGTON: It was at the
- 18 point right behind that point here, in the old
- 19 business.
- MR. GLYNN RYAN: Okay.

11	RAB receiving draft and final versions of the EE/CA,

17	again, is these comments and the Army's response to
18	those comments for all three of the agencies that I
19	mentioned. And these were a basis for our discussion,
20	too, at this meeting.
21	The reason for the meeting was
22	really the lack of progress, I think, in terms of
23	getting through some of the tough issues that were

1	associated with the landfill EE/CA. So, people at our
2	higher levels, Philip's boss and his boss and Doyle's
3	boss and his boss' boss and my boss and his boss, and
4	the JPA were at this meeting where this discussion
5	alluded to the fact that we needed to get together and
6	try to move some of this forward, which has also been
7	an issue. And there was two objectives that came out
8	of this discussion that said, okay, have a meeting and
9	the two things we want to see you do is we want you to
10	decide which landfills stay in the EE/CA and which go
11	to an RIFS or full remedial investigation feasibility
12	study.
13	And then they wanted us to address
14	any of the data gaps that were associated with
15	completion of the EE/CA or an RI for the landfills.
16	And I think it's important to point out again that the
17	meeting was attended by the EPA, ADEM, Army, the JPA,
18	and the JPA's contractors, to include our contractors,
19	the Army's and EPA's contractors.
20	It was well received by the members
21	of the BCT. I think all participants provided input

3	issues identified in the comments that were provided.
4	Actions defined, here in this briefing that I'm about
5	to these slides I'm about to go through, were a
6	result of many of those comments.
7	The next slide that's in your packet
8	there is a slide of the landfill areas. I also had
9	put it up on the board.
10	MR. MONTY CLENDENIN: You looking
11	for a little pen?
12	MR. RON LEVY: Yeah.
13	MR. MONTY CLENDENIN: Right at the
14	head of your notebook.

16	things I want to point out, this is the map showing

3	out of our meeting. But that just represents what was
4	in the EE/CA at the time. In fact, at the time it
5	went out for public comment.
6	The first landfill that we discussed
7	was landfill one.
8	MAYOR WILLIAM KIMBROUGH: Ron,
9	excuse me. Are any of these landfills actively being
10	used or being used now?
11	MR. RON LEVY: No, not actively
12	being used.
13	MAYOR WILLIAM KIMBROUGH: Okay.
14	MR. RON LEVY: Even to include the
15	construction, the debris landfill, which we have a
16	permit on, but it's not being used.
17	Per our objective, we that first
18	objective, whether it goes stays in the EE/CA or
19	goes to an RIFS, we agreed that this fill area would
20	stay in the EE/CA. We also agreed to conduct a
21	landfill gas monitoring to ensure that methane gas was
22	not at issue. This was a recurring comment from ADEM
23	for most of the fill areas. And, Philip, Doyle, you

1	can just jump in any time you want to to add to my
2	discussion.
3	Also, to close some data gaps that
4	were addressed by the JPA, we agreed that we'd take
5	some additional sampling of the locations that were
6	defined by the group. That's reflected in the
7	collection of the four sediment samples. This was
8	talked about extensively by the group with JPA a
9	great amount of JPA input.
10	What we essentially agreed to was
11	that we would provide a one foot soil cover, where
12	waste was exposed, there would be land use controls
13	associated, and that we'd put monuments to define the
14	perimeter.
15	We also wanted to clarify the
16	conceptual site model. And just so you understand, a
17	conceptual site model is something that is developed
18	to provide kind of an initial understanding of
19	potential site contamination, to help formulate an
20	approach to conducting the investigation. A
21	conceptual site model might include a summary of the
22	sources of contamination, mechanisms of contamination
23	release. But two particular areas that they wanted to

- 3 In landfill number three, what we decided to do,
- 4 proposed to do is to remove it completely from the
- 5 EE/CA and combine it with the ongoing remedial
- 6 investigation for groundwater and address both the
- 7 soil source issue, along with the groundwater. So,
- 8 what that means, in terms of what the final remedy
- 9 might look like -- and it should come out in that
- 10 actual document -- was that you could see land use
- 11 controls, you could see monuments and soil cover cap,
- and then you could see also additional work as it

12	is that the Army used the landfills and called them
13	sanitary landfills for purposes of debris coming from
14	households and in typical type landfills that you see
15	that receive household waste. Whereas, the other fill
16	areas may be related to something where we just
17	decided to put some debris from a construction site or
18	inert-type material, more than likely.
19	But, you know, whereas landfills
20	were labeled one through four, because they were
21	sanitary landfills, and putrid-type waste may have

gone in there, all sorts of things that might have

been significant, in terms of a fill area. Whereas,

22

23

- 1 the others are probably less significant, in terms of
- what went in there. 2.
- 3 MAYOR WILLIAM KIMBROUGH: So, in a
- fill area, you would have probably a less variety than
- 5 you would in a landfill?
- MR. RON LEVY: Yeah, to put it
- 7 simply, yes.
- 8 MAYOR WILLIAM KIMBROUGH: Okay.
- 9 That's the way I would have to put it.
- 10 MR. RON LEVY: So, that was the
- fill area north of landfill two. 11
- The next was fill area east of 12
- Reilly Airfield, the former post -- post garbage dump. 13
- 14 That's this area up here. And although I haven't
- defined background -- I mean, fill area east of 15
- Reilly, is about four point five acres in there with 16
- 17 about two related to the former post garbage dump.
- Let's see. Again, this one we 18
- 19 elected to keep it in the EE/CA. We agreed to do some
- 20 soil monitoring or some landfill gas monitoring.
- 21 Another well to the west on this side over here,
- 22 really to fill a data gap that was identified relating
- 23 to metals, not that we expect to see something there,

- but to be absolutely sure that we can say definitively
- 2 that there isn't anything.
- Remove surface debris. One foot
- 4 soil cover on the fill areas only. Land use controls.
- 5 Again, monuments to define perimeters. The same kind
- 6 of stuff that you've seen in the others. Clarified
- 7 conceptual site model.
- 8 And then we got into a discussion as
- 9 it relates to the wetlands. You see this blue area up
- 10 here on the top, it's a wetland. And underneath this
- 11 label here is actually where Reilly Lake is at. And
- 12 then there is another wetlands off on the left hand
- 13 side. I don't have a better map that I could show it
- 14 to you on.
- 15 But what we did do as a group is we
- 16 recommended that we investigate the wetlands based on
- some of the metals that were seen that were above the
- 18 screening levels for eco values and also the concern
- of the proximity to the recreational resources, i.e.,
- The City of Anniston's desire to put a park in that
- 21 place. So, what was discussed was thought to
- delineate metals.
- 23 And again, we have not scoped any of

1	this stuff out, yet. We do have some thought to get
2	out on the ground here shortly and look at it. One of
3	the other issues too that came up, that Miki Schneider
4	brought up was a concern for the possibility that
5	there may be mercury in the as it relates to the
6	food chain or fish. And the Army just doesn't believe
7	that's the case. But to eliminate that as an issue,
8	we talked about doing an evaluation of potential
9	for the potential for mercury there.
10	Also, looking at doing as part of
11	that, doing an ecological risk and a human health risk
12	assessment. Did I you guys have anything further
13	about that one? Want to add anything to it?
14	MR. DOYLE BRITTAIN: You did good.
15	MR. PHILIP STROUD: No.
16	MR. RON LEVY: Okay. The next one
17	is the fill area northwest of Reilly Airfield.
18	Again, this one, we agreed to keep it in the EE/CA.
19	Some landfill gas monitoring.
20	Another data gap issue that we
21	addressed as we discussed it and let me just point
22	out this area this is the fill area that I'm

talking about right here. And directly to the north

23

1 of	that,	for -	- the	discussion	for	another	well	that
------	-------	-------	-------	------------	-----	---------	------	------

- 2 would look at metals, explosives, VOCs, so that we can
- 3 absolutely close the door on any potential
- 4 contaminants associated there.
- 5 We also discussed desire to --
- 6 debris removal, one foot soil cover, land use
- 7 controls, monuments to define perimeter, and again,
- 8 the conceptual site model clarifying that in the
- 9 document.
- 10 MR. SCOTT BECKETT: Ron, I'm just
- curious, what does the phrase "on fill areas only"
- mean? I mean, I'm just curious, because it's there
- for every one.
- MR. RON LEVY: Well, I will tell
- 15 you, if you look at these, some of these shapes up
- 16 here, it's an area as opposed to where the fill is
- 17 actually at. So, if you look at some of the
- 18 geophysical investigations, you might see exactly
- 19 where the fill is at, as opposed to that entire area.
- 20 MR. SCOTT BECKETT: Okay.
- MR. RON LEVY: So, it's not over the
- 22 entire surface, it's just where we see debris and the
- fill is coming up.

1	MR. SCOTT BECKETT: Okay.
2	MR. RON LEVY: The last one, fill
3	area at range thirty. And I'll point to that. That's
4	right in here. It wasn't as everybody looked at,
5	there really wasn't any data to say that this
6	presented any human health ecological risk, as well.
7	Doyle and EPA recommended that we move the asphalt
8	debris out there, as it's a possible RCRA waste or it
9	could be considered as a RCRA waste, so we talked
10	about removing that.
11	And then there was a seep location
12	that was mistakenly well, it wasn't mistaken it
13	was addressed that people could have construed there
14	was actually in the middle of the fill area, so we
15	wanted to change the text to clarify exactly where
16	that seep area was at.
17	That is a totality of what was
18	discussed and we tried to come to agreement on at the
19	BCT meeting. And I'll let Doyle and Philip say
20	anything further to this, if they want to. And then
21	we can open it up for discussion.
22	MR. DOYLE BRITTAIN: I don't have
23	anything else.

1	${\tt MR}$ .	PHILIP	STROUD:	Not at	this

- 2 time, I don't.
- 3 MR. RON LEVY: We'll be glad to
- 4 take questions. Thoughts.
- 5 MAYOR WILLIAM KIMBROUGH: What's
- 6 the next step then?
- 7 MR. RON LEVY: Well, I think the
- 8 next step is the privatization piece because it's in
- 9 the midst of negotiation. So, we're kind of going to
- 10 wait to see what happens. We obviously want to move
- 11 forward, but if it gets negotiated and something that
- 12 goes to the JPA to do, then this may become a baseline
- for the work that gets done. Or something more might
- get negotiated, I just can't tell you.
- MAYOR WILLIAM KIMBROUGH: So, if --
- Matrix, they'll be reviewing this?
- MR. RON LEVY: In fact, Matrix was
- 18 involved in this meeting. They were actually there.
- 19 MAYOR WILLIAM KIMBROUGH: Okay.
- 20 And so they'll actually be negotiating with the
- 21 Government hopefully before --
- MR. RON LEVY: It -- Matrix --
- MAYOR WILLIAM KIMBROUGH: --

- 1 September --
- MR. RON LEVY: -- in representing 2.
- 3 the JPA would --
- MAYOR WILLIAM KIMBROUGH: So, this
- 5 could change then?
- MR. GLYNN RYAN: Oh, yeah. This is
- a -- what we are looking at today, with this
- 8 negotiation, everything is on the table. I mean,
- 9 that's a --
- 10 DR. MARY HARRINGTON: Additional
- 11 questions? Thank you, Ron, for the report.

- 8 resignation of Mr. Cunningham and Mr. Freeman. And I

- 3 DR. MARY HARRINGTON: That's what

- 5 MS. BRENDA CUNNINGHAM: I have
- 6 ballots, so, if they have members that they want to
- 7 add to these ballots tonight or we can wait.
- BR. MARY HARRINGTON: I have a new

- 11 MR. JIM MILLER: I think we need to

- DR. MARY HARRINGTON: So be it.
- 14 Apparently, everybody else is feeling that same way
- since nobody is saying anything. Is that the wishes

- Now we're going to just move into
- 18 the agency reports then. ADEM and EPA, give me what
- 19 you got.
- MR. PHILIP STROUD: Okay. We have
- 21 been busy. And one of my biggest issues lately has,
- of course, been along the UXO line, have a lot of
- issues dealing with that. I'm going to go ahead and

- 1 pass this around. If this isn't enough, we'll sure
- 2 get some copies.
- 3 First page will be documents
- 4 received this last month. Second page will be
- documents that have been going out the door, and some
- 6 of the letters we've been putting out the door, also.
- 7 We're also in the midst of finishing
- 8 up several more. You can almost mass (phonetic) this
- 9 page here of other letters going out so -- and we've
- been -- we're starting to get a lot more ADEM support,
- 11 which is a great joy at the same time. And Mark and
- 12 Brandi, you'll see their names on here.
- 13 And so, we appreciate your patience,
- 14 also. And as we get into the more complicated reports
- 15 coming down the road here, this list will probably go
- down just a little bit. But understand, if we go
- 17 through a privatization, then this list will probably
- 18 double. I hear all kinds of things.
- 19 But anyway, this is where we are.
- 20 If you have any questions on this, just feel free to
- 21 ask or talk to us. If you see anything we need to
- change, let us know, we'll correct this.
- MR. DOYLE BRITTAIN: Passing around

- 1 a list of the activities that I've done since the
- 2 February RAB meeting. And as you can see there,
- 3 it's -- I've reviewed fourteen different documents,
- 4 submitted comments on them or approval letters, one or
- 5 the other.
- 6 And on the second page there, you
- 7 can see that I've attended ten different meetings.
- 8 And I won't bother to read all that to you, but I'll
- 9 let Sam incorporate it by reference. If you have any
- 10 questions, I'll be glad to try to answer those for
- 11 you.
- 12 MAYOR WILLIAM KIMBROUGH: I notice
- 13 you attended a training course for UXO. Are y'all
- going to get back into UXO?
- 15 MR. DOYLE BRITTAIN: I don't know,
- that decision has not been made, yet.
- 17 DR. MARY HARRINGTON: Is there any
- 18 additional questions? You guys have been busy.
- 19 There is no one here from JPA. And I have not
- 20 received anything, have you all?
- 21 MR. RON LEVY: Not heard anything.
- 22 Brenda, did JPA --
- MS. BRENDA CUNNINGHAM: (Shakes

- 1 head.)
- DR. MARY HARRINGTON: And I feel 2.
- 3 certain that the technical review committee has
- 4 nothing. Do we?
- MR. RON LEVY: Well, Ron Grant did a
- 6 review. I don't know if he wants to --
- DR. MARY HARRINGTON: I haven't got
- 8 down to TAPP, yet.
- 9 MR. RON LEVY: That's right, I'm
- 10 sorry.
- DR. MARY HARRINGTON: 11 I'm on the
- 12 technical review. We're down to our action summary
- 13 sheet.
- 14 MR. RON LEVY: Yeah. Instead of
- the long, drawn-out walking through each piece of 15
- detail, let me see if I can't point out maybe some of 16
- 17 the high points. As it relates to landfill number
- three, the off-site groundwater monitoring and the ten 18
- additional wells, as of this writing of this 19
- particular report, there was eight done. For those of 20
- 21 you who know, we are drilling in the median of
- 22 Highway 21, almost at the northernmost edge of what
- 23 Fort McClellan is.

1	It's that particular well, we're
2	looking at it almost three hundred foot in depth, at
3	this point. And they're still working on it. I don't
4	have a particular date when that's going to be
5	completed.
6	There has also been a private well
7	spring survey done. Some of that information is going
8	to be presented to the BCT this week. Certainly, we,
9	at some point, will be glad to show that to the RAB,
10	as well.
11	We've completed groundwater
12	monitoring samples for landfill three in March. These
13	included City of Weaver's wells, Mr. Brown's property,
14	some of the ones on Blarney Drive. And I'm not aware
15	of any significance to any of that sampling, though,
16	we haven't seen anything come back, at this point.
17	In the OE investigations, Alpha area
18	EE/CA, the public comment period on the EE/CA report
19	was March to the 2nd of April. And we did a public
20	meeting on the 18th of March.
21	Bravo area, we're working the draft
22	report. The Y (phonetic) removal area in for those
23	of you who know don't know where that is, it's this

1	area up	here.	Can	you	see	where	I'm	pointing,	against
---	---------	-------	-----	-----	-----	-------	-----	-----------	---------

- 2 that wall over there? You see where that little
- 3 pointer is? That's that area right in there. That's
- 4 currently ongoing. And don't have a projected
- 5 completion date.
- 6 Charlie area report, the Army's
- 7 currently reviewing the draft -- as of this report, is
- 8 currently reviewing the draft EE/CA report from
- 9 Huntsville and the contractor. So, we expect shortly
- 10 to be sending that report to the State.
- 11 M-101, we submitted a removal report
- 12 to ADEM for review. And there is comment review
- 13 resolution going on between that. I understand that
- Ron has got some information, in terms of his review
- of some of that.
- 16 Eastern bypass, we're still working
- 17 a draft removal report on that for submission to ADEM.
- 18 So, for the most part, their work has been completed
- 19 within the eastern bypass. And we're just working the
- 20 removal report at this point.
- 21 We talked about the landfill EE/CA
- actions and what's happening there, so I won't go into
- any of that.

1	The FOSTs that are out there are
2	listed. I'd like to point out that the Army
3	provide the ECOP for Fish & Wildlife Service, which
4	is on a fast track to get the property transferred.
5	The Army provided the final ECOP and responses to
6	comments to EPA and ADEM on the 8th of April on that.
7	Worked through their comments and write responses.
8	So, we're trying to meet (phonetic) that property so
9	that there could be a signing the last week in May,
10	Glynn.
11	MR. GLYNN RYAN: I don't know.
12	MR. RON LEVY: Property transfers,
13	deed nine is being processed through Army channels.
14	That's actually the PX area. And then you can see the
15	number of folks from the Corps, contract staff that
16	are on post during this time period.
17	As always, we're concerned about
18	safety, folks going through roadblocks and whatnot on
19	post, are potentially putting themselves in harms way.
20	We ask people not to do that.
21	I'll take any questions.
22	DR. MARY HARRINGTON: No questions?

Okay now, we're down to our TAPP report.

1	MR. RON GRANT: There is, in your
2	package some information (inaudible) from my review,
3	comments on the
4	MS. SAMANTHA NOBLE: I'm sorry, Ron.
5	MR. RON GRANT: Beg your pardon?
6	MS. SAMANTHA NOBLE: A little louder
7	for me, please. Sorry.
8	MR. RON GRANT: It's kind of hard to
9	overcome this blower back here.
10	In your package, there are some
11	my review comments on the finding of suitability for
12	transfer for the eastern bypass, tracts two and three.
13	And I've got just a brief summary of that that I'll,
14	you know, go over.
15	MS. DONNA FATHKE: Ron, what does
16	that document look like?
17	MR. RON GRANT: The one you're
18	looking for starts off is about three typed pages
19	and the heading is review of Army responses to
20	regulatory comments, dated January 21, 2003.
21	MS. DONNA FATHKE: Thank you.
22	MR. RON GRANT: Just a brief summary
23	of those three pages. ADEM comments that OE UXO

1	fragments/scrap are indicative of a historic impact
2	range and the clearance should be to depth. But the
3	Army contends that there is no data to support ADEM's
4	claim; training items found on the parcels do not
5	contain charges and practice items have a small
6	charge. So, there is still some obvious disagreement
7	there.
8	Clearance to depth data in the M-2
9	parcel adjacent to OE S1 is cited by the Army as
10	supportive of its position, due to the lack of high
11	explosives found there. ADEM also questions the
12	transfer of the M-2 parcel because of unresolved
13	comments from EPA. The Army comments that both EPA
14	and ADEM concurred with the transfer in June, July
15	2000 time frame by letter and considers this to be a
16	non-issue.
17	Another ADEM comment. ADEM
18	questions the sufficiency of equipment used to detect
19	subsurface ordnance greater than one foot depth on
20	tracts two and three. The Army states the equipment
21	is capable of detecting items deeper than one foot.
22	Another ADEM comment. ADEM requests
23	explicit/extensive information and data on work

performed on tracts two and three in a letter of
3 December '02 and 24 December '02 and says that that
still has not been received. The Army references
reports and letters that attempt to address ADEM's
data needs.
Another ADEM comment. ADEM
questions category one, determination. It says the
Army used data from the M-2 CERCLA site investigation
to infer that tracts two and three are category one.
And that's just a brief summary of
what's in those three pages.
MAYOR WILLIAM KIMBROUGH: If ADEM
and EPA make comments, can properties be transferred
before those comments are cleared?
MR. GLYNN RYAN: Yes.
DR. MARY HARRINGTON: So, what
you're saying is: Even if ADEM and EPA have feel
like they have sufficient concerns, they won't stop
and wait and say, ye, nay and prove them wrong or
right?
MR. GLYNN RYAN: We can transfer

- 2 MAYOR WILLIAM KIMBROUGH: Has there
- 3 any been transferred, Mr. Ryan?

- 7 the attempt to get an extension? We talked, I think,
- 8 about that briefly last time.
- 9 MR. RON LEVY: I can tell you that
- 10 we're in discussion with Ron Grant about it at this

- MR. RON LEVY: Just to bring you up
- to date, five hundred hours was the amount of hours
- 16 that we started with under Ron Grant's contract. And
- 17 during the March, April time frame, Ron billed for
- 18 sixteen of those hours. So, that left four hundred
- 19 and nine point seven five hours.
- The way TAPP works under the Army is
- 21 that the Army can provide technical assistance under
- 22 this contract at twenty-five thousand a year, up to a
- 23 maximum of a hundred thousand. So, certainly, at this

1	point, Ron did not use a significant amount of his
2	contract. And we're entering the May time frame for
3	the renewal of the contract.
4	DR. MARY HARRINGTON: Okay.

MR. RON LEVY: I would also

mention, too, that should we work this -- be able to

work this out, the RAB will need to, in terms of

utilization of Ron and his technical assistance, have

9 to step up and define things that they think that Ron
10 can be used for. It doesn't necessarily have to -- as
11 it relates to these sites that we're (inaudible), in

order for him to truly get, you know, the use out of

13 his contract. So, he's there for your -- for the

14 RAB's assistance. Not specifically the Army, but for

the RAB's assistance.

And what really needs to happen is
the RAB to define issues that they want explained, in
terms that they can understand. And that's what Ron
is here for. He can go into a document, try to
interpret -- or at least try to boil something down
from a technical standpoint so that the RAB can

2	last meeting, we discussed and it gets into the
3	next one, but there seems like there might have been
4	some confusion and I don't know if I was clear last
5	time on it that we had been told that he could only

19	sufficient?
20	MR. RON LEVY: That's different
21	than what you asked me, looking at other alternatives
22	or define other alternatives as a technical
23	standpoint. I don't see why Ron could not do that, as

- 1 he looked at a document. That's not the same thing as
- 2. taking -- you know, taking a document and going
- 3 through it and trying to provide you comments for it,
- which is some of what I understood was part of the
- 5 discussion.
- But looking at something from a
- technical nature, maybe even looking at other
- 8 technologies certainly would be in the scope of what
- 9 Ron's job is.
- 10 MAYOR WILLIAM KIMBROUGH: Well, for
- 11 one instance, Ron, there has been issue brought up
- about UXO and the one foot versus three foot. This 12
- issue has come up, you know, after we have gotten the 13
- 14 document, and which y'all have gone through the EE/CA
- 15 and everything. And so, you know, could he, prior to
- 16 that, when he was reviewing the original -- because
- 17 that you gave it before it went -- went into your --
- with EPA and ADEM and all, could he advise us on that? 18
- 19 That's what we're trying to (inaudible).
- 20 Because we don't know, until it was
- 21 brought up -- I think Pete went -- we didn't -- we
- 22 didn't understand or we'd never been made aware that
- 23 there was an option to go to a -- from a one to a

1	three foot clearance in some of these. And that seems
2	like that has been an issue. As a matter of fact, I
3	think that was what I discussed with you earlier;
4	there is an issue between ADEM and y'all on some of
5	the bypass, on the one foot to three foot clearance.
6	And so and this is something that
7	I was made aware of through the MPO discussions with
8	the Department of Transportation last week.
9	MR. RON LEVY: I'm not sure what
10	the question is there. But if he's looking at a

was a possibility. I didn't. I don't know about

1	problem, too, is Ron has not seen those documents up

12	MR. RON LEVY: He's supposed to be
13	providing you technical expertise. See, that's always
14	been a problem, to say, okay, go in the review go
15	in and review this document and tell us everything
16	that's wrong with it, that's not his function.
17	DR. MARY HARRINGTON: I don't think
18	he meant it like that. I think he was meaning from a
19	standpoint, now I've read this and I understand this
20	and this and this, is there something that I may have
21	overlooked that's more serious than this?
22	MR. RON GRANT: If there is a
23	specific request of some kind of course, it needs

- 2 scope of work -- if you'll address it to him, he can
- 3 request it of me. And if you have a criticism of what
- 4 I've given you so far, if there is something that you
- 5 feel like -- if I'm missing the point in what you want

- 7 too, so that I can change the direction or the flavor
- 8 of what I'm presenting to you.
- 9 MAYOR WILLIAM KIMBROUGH: I guess
- 10 part of it is sometimes we don't know the questions to

- 12 MR. MONTY CLENDENIN: That's what I
- 13 was trying to get at.
- 14 MAYOR WILLIAM KIMBROUGH: What we're
- 15 asking is: Would it be allowable if you saw something
- in there that you think there might be a question on,
- 17 for you to refer that back to us on like an EE/CA or
- 18 something like that?
- 19 DR. MARY HARRINGTON: That's a chief
- 20 concern that has been sent to me a couple of times.
- 21 And I heard you say, if it's a specific request. But
- 22 if this board could act in terms of that specific, we
- 23 really wouldn't need anybody to decipher it out for

- 3 what we're reading it might be the practical and the
- 4 best to do, but then we -- that's where it gets off,
- 5 because that's not our expertise and we don't know
- 6 specifically what would have been the better idea or a
- 7 simpler idea or even the safest idea.
- 8 So, I think that may be swearing the
- 9 members off when you say, be specific, because it's
- 10 kind of difficult to be specific.
- 11 MR. RON LEVY: See, the way this
- 12 really kind of works is the regulators are asking the
- questions, you know, why didn't you do this or why
- 14 haven't you gone in this direction. And Ron's job
- really is to help you understand, you know, those
- issues and boil them down in terms that you can
- 17 understand and maybe even decide which questions you
- 18 want to ask from that.
- I mean, your job is to ask the
- 20 questions. He's there to interpret what the data says
- 21 or what the technology is about, help you understand
- that. That's technical assistance.
- 23 MAYOR WILLIAM KIMBROUGH: But we

- don't get that until the decisions have already been
- 2 made. Because by the time you go through your
- 3 committee and your questions and you agree -- just
- 4 like this document that we got tonight, y'all have met
- 5 and if we're an advisory board, we're not advising on
- 6 anything, we're just listening.
- 7 MR. RON LEVY: Well, in the case of
- 8 the landfill EE/CA -- because no decision has been
- 9 made, actually, you know, there has not been any
- 10 action memorandum signed or decision document signed.
- 11 I mean, that's still out there. It's the same thing
- 12 with -- well really, Alpha area EE/CA, I mean, they're
- out there. They're -- there has been no decisions
- 14 made.
- 15 It really requires the RAB to step
- 16 up. And you have in some cases, you've said, okay, go
- 17 ahead and look at the FOST comments and tell us what
