2	you, take just a moment to review those. And if there
3	are any changes or any additions or whatever, please,
4	call those to the committee's attention.
5	MR. JIM MILLER: Move that we
6	accept.
7	MR. MONTY CLENDENIN: Do I hear a
8	second?
9	MR. JAMES BUFORD: Second.
10	MR. MONTY CLENDENIN: Everybody in
11	favor say aye.
12	(Ayes were in favor of.)
13	MR. MONTY CLENDENIN: Any opposed,
14	no.
15	All right. Is there any old
16	business before the RAB that we need to act on? Any
17	old business? Anybody got something up their sleeve,
18	an old grudge, anything we wanted to pull out of the
19	closet? Okay. All right.
20	Let's move on to program then. I
21	guess I could say, Ron, if you want to say anything
22	we, at the pre-RAB meeting, we did not discuss
23	anything and have nothing to bring to the group

1	tonight. Do you want to add anything to that?
2	MR. RON GRANT: No.
3	MR. MONTY CLENDENIN: UXO issue,
4	T-O-S-C, TOSC, whatever that means. Who is going to
5	make this presentation?
6	MR. BOB SCHMITTER: That's me.
7	Those of you on the RAB have a copy
8	of the OE UXO report that TOSC put together. We were
9	asked to put a report together by the RAB,
10	specifically, Pete Conroy and Barry Cox. The request
11	came, asking TOSC to cover some general UXO issues,
12	methods of assessment in the Bravo area and the
13	eastern bypass, and also to provide some input on some
14	issues of concern that may have arose as we took a
15	look at the report.
16	Those of you I apologize if you
17	don't have it, I didn't make enough copies of that,
18	but if you need a copy of that let me know, so we can
19	get you one, Brenda can get a copy for you at the next
20	(inaudible).
21	A couple of limitations on the
22	report, as we always need to do, put some disclaimers
23	in there, but for one, the TOSC is really set up as an

1	environmental entity within an EPA grant, so, UXO is
2	not really our expertise. So, I'll admit at the front
3	end that there are a lot of things, UXO issues, that
4	we're still trying to understand. But hopefully, this
5	is the beginning for us to begin to provide some
6	information, additional information to the
7	Restoration Advisory Board and get some of your
8	questions answered as we go forward.
9	We looked at a couple of different
10	reports, a couple of different publications, if you
11	will, that were provided to us by ADEM, by Ron Levy,
12	and the Army, and other things that we have come
13	across in our library and our search for this. By no
14	means is the material that we looked at complete. We
15	don't have enough time, nor enough resources to do
16	that. But I think that what we looked at is fairly
17	representative of some of the issues that we needed to
18	take a look at.
19	Your back page on your report has a
20	list of the documents that we did review of this
21	particular report that we're presenting here. We
22	understand there is more information out there, and as
23	I said, we hope this could be a start to some

additional questions and answers and research as we	go
---	----

- 2 forward.
- And as we look at the Bravo area,
- 4 and we looked at the EE/CA conducted by
- 5 Foster Wheeler, dated October 2003, that, of course,
- 6 evaluates the presence of OE, and recommended the most
- 7 feasible and cost-effective approach to reduce the
- 8 risks. That EE/CA was performed in accordance with
- 9 CERCLA and the National Contingency Plan as the
- 10 standard procedure there.
- 11 Real generally, the ordnance fired
- into, if you will, the Bravo area or used in the Bravo
- area included grenades, rockets, mortars, small arms
- fire and etcetera; so, that's what we're looking at in
- terms of our investigation, other investigations
- 16 (inaudible) --
- 17 MR. PHILLIP BURGETT: Could you
- 18 define for those of us who is new what the Bravo area
- 19 is.
- MR. BOB SCHMITTER: Bravo area,
- 21 let's see, it's exactly right there. (Demonstrating.)
- 22 Right there, the orange one.
- MR. PHILLIP BURGETT: Okay.

1	MR. BOB SCHMITTER: From this, from
2	this investigation that Foster Wheeler conducted,
3	response actions were based on that. Also, the amount
4	of ordnance or explosives found we'll talk a little
5	about this later and how it fits into some of the
6	areas, the risk sector areas that were delineated by
7	the report, as well.
8	Assessment of the Bravo area was
9	conducted using geophysical methods, electromagnetic
10	induction in the EM61 process, if you will. There are
11	pros and cons of the EM61, those are listed in your
12	report. I don't feel the need to get into that right
13	now.
14	But for the most part, as with every
15	method that you're going to use for conducting the UXO
16	assessment, there will be some limitations to the
17	mechanics involved with it.
18	The sampling itself, based on field
19	reconnaissance, historical data, topography, transects
20	walked within the area, based on accessibility of the
21	areas, mountainous terrain, wooded areas, etcetera,
22	etcetera.

From this, areas of the Bravo area

1	were delineated as high, medium or low, regarding the
2	potential for the likelihood of finding OE on the
3	site. Again, you can see page four how these are
4	listed, in terms of potential.
5	Just for clarification on that, you
6	see the list there, like A1 reconnaissance area, those
7	numbers, cap the last letter, if you will, in the
8	first four indicates that probability; H, high; M,
9	medium; L, Low, obviously.
10	Also, on that listing there, you can
11	see at the end of each classification the grenade area
12	D, indicates that there will be some future type of
13	disturbance, most notably through development. PR,
14	which just means passive recreation, no intention of
15	disturbance expected in that area, which brings us to
16	a point I'll touch on later, as far as institutional
17	controls and making sure that those things will indeed
18	be enforced.
19	The Bravo area is divided into ten
20	sampling sectors based on, again the geographic
21	limitations, boundaries, topography, etcetera, and
22	also looking at what would be expected in this
23	particular area.

1	From that sampling area, sampling
2	sector, sector risk areas were identified. There are
3	eighteen of those, and those are also on page four and
4	you can see where those are listed in there.
5	The Corps of Engineers, ordnance and
6	explosive risk assessment impact analysis was used to
7	help identify those areas, categorize those into the
8	risk sectors.
9	Also, in that Corps of Engineers
10	publication, risk factor categories, looking at OE
11	type, (inaudible) sensitivity, how something might be
12	prone to going off or detonating, quantity of
13	material, density of material, where there is a lot of
14	fragments, a lot of UXO in there, and the depth that
15	the OE penetrated into the soil.
16	Also, have the site characterization
17	factors, accessibility of the area, how accessible is
18	the area to the general public, children, anybody who
19	may be living or working on the post, itself. The
20	stability of the area, likelihood of it being
21	disturbed through normal activity, or maybe future
22	construction type of work.
23	Also, human factors, baseline risk

2	alternatives.
3	From that sampling plan and from the
4	other work that was done by Foster Wheeler in the
5	Bravo area, they went ahead and put they list four
6	recommended response action alternatives, and you can

The eastern bypass area, the only document we had to look at on that was the latest final report, dated March of this year, being put together by Foster Wheeler, and that indicates a lot of the issues for sampling, assessing that area. Focused on specifically ordnance and explosive site

two, OES2, which is basically the north sounth main

23 running area along that eastern bypass.

1	Within that particular OES2, there
2	were two areas that were found to be, I guess you
3	might say, fairly heavily impacted by OE. That would
4	be the rocket city area on the northern part and the
5	construction debris area, which had a lot of different
6	things in it, not only OE, but construction debris, as
7	well, metal, things like that, which tend to influence
8	the assessment of that area.
9	That area, the OES2 area, within the
10	eastern bypass, also, overlaps some of the firing
11	ranges within the Bravo area, which is why that
12	particular area of the eastern bypass received a
13	little bit more attention than some of the other areas
14	within the eastern bypass. Rocket City area,
15	construction debris area were both areas that had
16	mechanical removal of OE and UXO through the armored
17	bulldozer and that sort of thing, to make sure that if
18	anything did go off, those folks were properly
19	protected?
20	MR. BOB SCHMITTER: Finally, the
21	last not the last page, page seven, I believe it
22	is, of your report, lists some of the concerns that
23	the TOSC program has, regarding the OE issue within

1	the Bravo area and the eastern bypass. Again, these
2	are fairly general, but what we're trying to do
3	hoping to do is give the RAB some information on maybe
4	some additional questions to ask the Army as they go
5	through and continue to take care of the OE in there.
6	One, which, looking at these in
7	order here, lack of a standard QA/QC protocol, if you
8	will, between the reports in the Bravo area and the
9	eastern bypass.
10	There are a lot of things referred
11	to in there; DOD 6055.9-STD, MIL-STD-1916, things like
12	that, all referred to in different parts of the
13	report. While they are helpful to the lay person, I
14	think what is needed is some sort of standardized
15	QA/QC procedure that can be taken and applied to each
16	area, whether it's on Fort McClellan or some other
17	post or base.
18	I don't know if there is one out
19	there. I may have missed it. Some of you guys from
20	the Corps or Foster Wheeler or Tetra Tech may know
21	more about that than I do. I did not see it in the
22	research that I did. I think that would be certainly
23	something that would be very helpful in understanding

Τ	the QA/QC process. I know between ADEM and the Army,
2	there have been some concern about making sure that
3	there is a good standardization as the QA/QC
4	procedures are done. I think that would be extremely
5	helpful for the RAB and others, as well, that are
6	concerned over the future development aspects within
7	these areas.
8	Also, we had a concern over
9	clearance criteria regarding clearance to depth. One
10	of the questions I had, I didn't see an answer, I
11	thought, very well within the report that I saw, is
12	the controlling factor, in clearance to depth, the
13	capability of the instrument, the EM61 or is it the
14	depth of the buried object. If there is only is
15	the EM61 or some other type of instrument goes only to
16	six or ten feet, depending on background noise,
17	etcetera, is there a possibility that some UXO could
18	be buried deeper than that? I know some small-arm
19	fire and that sort of thing may not go that deep, but
20	again, for some other portions of the site or some

other bases, that's something, I think that would be

necessary to be answered. Is it the instrument or is

it the depth of the actual buried object, itself?

Τ	Lastly on there, institutional
2	controls, that's one of the response actions that was
3	put forth in the EE/CA. And the problem is, we've
4	always found with an institutional control is making
5	sure that those things are enforced over time. It's
6	great to put something in the deed saying you can't
7	disturb this property without proper authority or
8	permission or a permit and that sort of thing, but how
9	many people really look at a deed when they're going
10	to buy property? Maybe somebody does, but the actual
11	property purchaser does not. They may be stuck
12	somewhere down the road with an unknown problem on
13	their land and they may not know it until it's too
14	late.
15	Essentially, these institutional
16	controls, whether it's through the Army and ADEM and
17	the Transition Force, or whatever, JPA working
18	together, to make sure that twenty years down the
19	road, these institutional controls aren't forgotten,
20	if somebody goes in and builds a house or digs a
21	foundation or puts in a swimming pool and finds
22	something the unexpected surprises that could
23	possibly be in there.

1	Those are the specific issues that
2	we have. We're happy to take any questions on the
3	report, itself.
4	MR. MONTY CLENDENIN: Thank you.
5	Any questions?
6	MR. DAVID STEFFY: I've got one. In
7	your review of the literature, did the Army or I'm
8	sorry, did the contractors assess the effectiveness of
9	their surveying technique?
10	MR. BOB SCHMITTER: Their QA/QC or
11	in anything?
12	MR. DAVID STEFFY: I mean, how
13	effective was this surveying technique, in their eyes?
14	MR. BOB SCHMITTER: In their eyes,
15	I'm sure it's fine.
16	MR. DAVID STEFFY: Was it 95 percent
17	effective at finding material or 50 percent effective?
18	MR. BOB SCHMITTER: I didn't get a
19	feel for that, to be honest with you. I know that in
20	some of the pre-work they did, I mean, they looked at
21	95 percent confidence in what they found, you know,
22	going through some of the testing.
23	I don't have a feel for whether or

1	not they got 95 percent of all that was there or 50
2	percent or 5 percent. And I don't know if they could
3	answer that. They would probably be better to ask
4	than I would, because I don't have an idea on that.
5	MR. MONTY CLENDENIN: Okay. Any
6	other questions? Thank you very much.
7	Okay. JPA update, Miki, is that
8	you?
9	MS. MIKI SCHNEIDER: That's me.
10	MR. MONTY CLENDENIN: All right.
11	MS. MIKI SCHNEIDER: You have an
12	information sheet. Matrix has been on the ground for
13	the last about month, six weeks. They are the company
14	that's doing the clean-up work for us from
15	Denver, Colorado. And they have been working in the
16	areas that you see on the sheet. They've been in
17	landfill one, two, and four. And then they have done
18	some work on the fill area that is east of Reilly
19	east of Reilly Lake, out by the old air field.
20	They worked collected some
21	samples in the chemical laundry area. Small weapons
22	repair, which is over by Hunjin, and then T-6, which
23	is on old Naylor Field, which is over by Auburn.

1	We are hoping to have a project
2	manager. We're interviewing three potential
3	candidates this week, and hope to have a project
4	manager on the ground next month, that's here working
5	for Matrix, full-time, at McClellan. Currently, their
6	office, they have one person in each division of the
7	office that is here.
8	And to that end, I'm going to pass
9	out the JPA's latest news letter. And on the inside
10	of that, you will see pictures and bios on all of the
11	staff from Matrix that we have here, working on a
12	daily basis or a weekly basis, whatever the case might
13	be.
14	The project management committee,
15	which was established by the Board, is also operating
16	now. That group is overseeing the clean-up on behalf
17	of the JPA Board. The members of that are
18	Major Chip Howell, Mayor Ed Kimbrough, Ken Joiner and
19	Craig Branchfield, and we will be appointing one
20	additional person from the City of Anniston, hopefully
21	next month at the JPA Board meeting. There will be a
22	total of five people that will be on a daily basis
23	meeting on a weekly basis with the staff, as we need

1	it.	overseeing	t.he	clean-up.

- 2 Probably, the biggest news going on
- 3 with us right now -- and I'll pass this out -- is
- 4 Music at McClellan. If you have not seen about it,
- 5 heard about it, we are working on that, be two -- the
- 6 last two Saturdays in May and the first two Saturdays
- 7 in June. It's going to be up on Buchner Circle, and
- 8 this is with the Alabama Symphony Orchestra, and we
- 9 are very excited about the opportunity. Mr. Conroy
- 10 has been instrumental in making this happen, and we
- 11 appreciate all Pete's work on that project.
- 12 I'll be glad to answer any
- 13 questions.
- 14 MR. MONTY CLENDENIN: Any questions
- 15 for Ms. Miki?
- 16 MR. JIM MILLER: Have the Matrix
- 17 people that you provide bios, have they ever worked
- together before or has that team just been recently
- 19 assembled?
- MS. MIKI SCHNEIDER: No, they have
- 21 worked together before.
- MR. JIM MILLER: What size company
- 23 is Matrix?

1	MS. MIKI SCHNEIDER: Matrix has
2	about thirty-eight or thirty-nine employees. They
3	have two offices, one in Colorado Springs and one in
4	Denver.
5	MR. DAVID STEFFY: Why was Matrix
6	chosen?
7	MS. MIKI SCHNEIDER: Because of
8	their expertise with working on closed military bases
9	with environmental work. They have successfully
10	negotiated at least two other ESCAs across the
11	United States on closed bases, and they were the best
12	team to do this work for us.
13	MR. MONTY CLENDENIN: Are they
14	organized and actually doing some removal or are they
15	just assessing?
16	MS. MIKI SCHNEIDER: They're a
17	characterization that was agreed to as part of the
18	ESCA funding in the first phase, and that's what
19	they're working on right now.
20	MR. DAVID STEFFY: I notice on your
21	sheet there is no information about landfill three, no
22	work's been occurring at
23	MS. MIKI SCHNEIDER: Right now,

1	we're not the Army is still doing some work on
2	landfill three. We are, too, but this is what has
3	happened in the first month. We're in fact,
4	this maybe this week, it may actually be next week
5	we actually do it. We're negotiating with some land
6	owners along Highway 21 to put in some additional
7	wells for landfill three. We were writing letters
8	today on that.
9	MR. DWIGHT MITCHELL: Speaking of
10	landfill three, the contamination plume that's headed
11	north toward Jacksonville, as I understood it, the
12	outer limits of that contamination have been defined
13	already, or has been defined; is that correct?
14	MS. MIKI SCHNEIDER: The northern
15	boundary of that plume has not been completely
16	defined, and that's one of the reasons we are putting
17	these wells in.
18	MR. JIM MILLER: Okay. Assume that
19	at some point in time the northern boundary is
20	determined, I know the characterization is going on
21	and what remediation would take place. I understand
22	that, you know, some of the remediation efforts on the
23	depo, are we looking at cleaning up the groundwater or

- 1 are we going to wait until it gets into someone's -- I
- don't know. I would like to know where they stand.
- 3 How far back --
- 4 MS. MIKI SCHNEIDER: I don't have
- 5 that answer for you, yet.
- 6 MR. RON LEVY: Let me add something
- 7 in there.
- 8 MS. MIKI SCHNEIDER: Okay.
- 9 MR. RON LEVY: First off, the Army
- does believe that it defined the most northern
- 11 boundary of that plume. However, we did provide JPA
- some additional money, because they had some issues
- 13 with completing the characterizations, they wanted to
- 14 complete the character- -- they felt that they needed
- to complete the characterization, and there were some
- 16 additional wells that they were going to put in to do
- 17 that. And we did provide them dollars.
- 18 But before they can make a
- 19 determination on the remedy, in terms of what they're
- 20 going to do, this characterization, on their part, has
- 21 to be completed.
- 22 MS. MIKI SCHNEIDER: That's right.
- MR. RON LEVY: So, that's down the

- 3 putting those wells in -- that's what we were looking
- 4 at doing today, was deciding where those go.

- 8 thought --
- 9 MR. RON LEVY: Well, we believe we
- bounded the plume, at least to the northern extent.
- 11 MR. DWIGHT MITCHELL: What were the
- 12 Army's actions, had they determined that that was the
- end -- I mean, was the --
- 14 MR. RON LEVY: We saw decreasing
- values -- in the last set of wells we put in, we saw
- 16 such decreasing values that we believe we had hit the
- 17 end of the plume. And, you know, off the top of my
- head, I can't tell you what the values were, at the
- 19 time. They were presented, I think.
- MS. MIKI SCHNEIDER: They were.
- 21 MR. DWIGHT MITCHELL: Yes, they
- 22 were. But my point was: What action would be taken,
- 23 if it -- if the Army had defined that that was the end

of it and JPA had not -- the privatization had not

2	taken place, what had the Army proposed to do?
3	MR. RON LEVY: Well, we didn't
4	propose anything. We did not go any further.
5	MR. DWIGHT MITCHELL: Well, let's

7 MR. RON LEVY: You know, I really

8 don't know. Again, if you're talking about

9 speculation, we may have proposed some sort of in-situ

speculate, what would you think? I don't know.

10 remediation, and I don't know what the JPA's proposal

is going to look like, either, but we may have gone in

The JPA really needs to complete their characterization before they can get to that

point, too.

13	involvement is, or at least to the extent that it
14	could, what the JPA's involvement and it's in one
15	of your hand-outs. It's entitled "Environmental
16	Services Cooperative Agreement" at the top.
17	And under the second paragraph,
18	"TSRS, public involvement", if you'll look down in the
19	middle of that big paragraph, it says that, "JPA will
20	provide and brief the RAB with information pertaining
21	to environmental services being conducted on the
22	ACES," which is the environmental

MR. GARY HARVEY: Area covered by --

3	environmental services.
4	MR. RON LEVY: by environmental
5	services maybe necessary. And that's essentially what
6	Miki is doing tonight.
7	There is other information in there,
8	in terms of their public involvement requirements.
9	But these were all questions asked by the RAB.
10	MR. MONTY CLENDENIN: Any other
11	questions about that? Is that clear to everybody?
12	All right, you wanted to
13	MR. GARY HARVEY: On this next one,
14	I had a couple of questions before. In fact, it was
15	from our staff, we put down an adjourning RAB,
16	adjourning terminating the RAB. And they thought
17	maybe I was trying to suggest something. We were
18	asked this question, you were provided it.
19	I don't do subtle things. Everybody
20	who knows me, knows subtle is not my strong point.
21	This was put here for information only. I'm not
22	suggesting we terminate the RAB, any of that stuff.
23	The question was asked, I think

1	Monty asked it I think it was you, but it doesn't
2	matter. Whoever asked it, it's there, and that's all
3	it is is for information. We are not terminating the
4	RAB or trying to.
5	MR. MONTY CLENDENIN: Is there
6	anymore information on that about this? Is this
7	something that's on somebody else's docket about
8	closure of the RAB? Okay.
9	Let's do the agency reports then.
10	ADEM and EPA, we got anybody for that?
11	MS. SHANA DECKER: I guess that's
12	me.
13	MR. MONTY CLENDENIN: Okay.
14	MS. SHANA DECKER: ADEM's been doing
15	a lot of work in the past few months. We've staffed
16	up, we've added two new employees to work on
17	Fort McClellan, including Labarron Rudolf and
18	Kajuana Rice, who are in the back. And we would like
19	to welcome them to the project.
20	In the past, we've been backed up
21	with some documents reviewing. And we are slowly but
22	surely catching up. I think we have reviewed several

documents, you'll see in the handout coming around,

23

1	that this is a three-month long list, since our
2	last RAB. We have a lot on there that we have
3	reviewed. We also have a lot on there that we have
4	received correspondence from EPA, from the Army and
5	also documents to review.
6	So, I want to point out that we have
7	been making a lot of progress reviewing documents that
8	we had backlogged. And we are speeding up, with the
9	addition of personnel, reviewing documents, as they
10	come in more readily. So, we're actually making a lot
11	more progress now than we have been.
12	We also have on that list the
13	documents that we have received, and we'll be getting
14	to those as quickly as we can. We've had several
15	meetings since the last time, regarding UXO issues in
16	with the Bravo area, trying to clear up our issues
17	between ADEM and the Army. I think we're coming to a
18	point where we've sort of made progress in that area.
19	We've also had to do some more
20	workshops since then. I was unable to attend because
21	of maternity issues.
22	But I think everything is going well
23	with ADEM. We've also started working with the JPA.

1	We're planning on coming up here a lot more often and
2	kind of keep an eye on the work that's being done
3	around here so that we can work in conjunction with
4	them and get their documents processed through a lot
5	more quickly like we should probably be doing all
6	along, and I think that's going to work out really
7	well. So, basically, that's it for now.
8	Do we have any questions?
9	MR. MONTY CLENDENIN: Any questions?
10	MR. DAVID STEFFY: Do you have
11	personnel on-site here to handle issues?
12	MS. SHANA DECKER: No, we don't have
13	any personnel on-site, we have to travel here. I'm
14	sure you've probably heard that ADEM has travel
15	restrictions between I think Governor Riley has
16	proposed a hundred-mile radius restriction; if we have
17	to travel within a hundred-mile radius, we can't stay
18	overnight. And Fort McClellan falls within a
19	hundred-mile radius, so, we can't stay overnight,
20	unless we stay for three days. It's really kind of
21	weird. But we don't have an office on-site
22	MR. JAMES HALL: It's a hundred
23	miles from Montgomery?

1	MS. SHANA DECKER: As the crow
2	flies, it's a hundred miles, but it takes two and a
3	half hours to get here. But it's a hundred-mile
4	radius, it's not the way you drive. If y'all could
5	fix that, that would be great.
6	So, to answer that question, no, we
7	don't have an office up here. We were talking today
8	about maybe having a little spot up here that we could
9	have between us and Matrix and whoever, just it was a
10	little small office in this little abandoned building
11	that we maybe could have to sit in it, have a little
12	base station back there, a phone, but that was just an
13	off-the-cuff kind of suggestion, I think. But, no.
14	MR. PETE CONROY: Kind of weird is
15	one way to put it, an absolute injustice would be the
16	other way to put it. The hundred-mile radius thing, I
17	understand clearly this is something that you all
18	would love to correct. But, Monty, I would recommend
19	from your chair, why not draft a letter for our local
20	delegation, Dale Marsh, and just remind them of this
21	issue. And it's not just Anniston, it's anyone beyond
22	them I mean anyone beyond. And it really is the
23	Alabama Department of Environmental Management, it

1	shouldn'	t be	, the

- 2 Department of Environmental Management within a one
- 3 hundred-mile range of Montgomery. Could we work on
- 4 drafting a letter that would help with that?
- 5 MR. MONTY CLENDENIN: Do I do that?
- 6 MS. MIKI SCHNEIDER: That's what you
- 7 get paid the big bucks for, darling.
- 8 MR. MONTY CLENDENIN: And do I have
- 9 stationery?
- 10 MS. MIKI SCHNEIDER: I bet Ron could
- 11 create you some.
- 12 MR. MONTY CLENDENIN: Okay, I'll try
- 13 to work with that.
- MR. PETE CONROY: I'll help you.
- MR. MONTY CLENDENIN: Okay. All
- 16 right. Help is on the way.
- 17 MS. SHANA DECKER: Excellent. Thank
- 18 you.
- MR. JIM MILLER: Don't hold your
- 20 breath, though.
- MR. PETE CONROY: Don't hold your
- 22 breath.
- 23 MR. MONTY CLENDENIN: All right.

1	Anything else for this group?
2	JPA report, we had that?
3	MS. MIKI SCHNEIDER: Had that.
4	MR. MONTY CLENDENIN: So, that's
5	your report there, too. Okay.
6	Action summary sheets, we have
7	those. Who is going to talk to us about those?
8	MR. RON LEVY: Yeah, that will be
9	me. I know that a lot of you well, let's see, at
10	least one of you have never seen any of this stuff
11	before, so it's probably what we just explained is
12	probably really confusing.
13	I can tell you that the work has
14	really wound down at McClellan quite a bit. Most of
15	it's a function of the funding that we've got, and
16	plus the fact that we gave forty-eight point five
17	million to the JPA to do the phase one clean-up. So,
18	when you pay Peter, you take away from Paul.
19	In any event, there is still some
20	work going on, both with Tetra Tech and Shaw. So,
21	I'll give you a little bit. Most of the work right
22	now is going on on the UXO side. And I'll point out
23	again, for those of you who don't remember or are not

1	sites, and there is we're clearing at the
2	present moment, we're in the process of clearing them
3	for UXO.
4	So, we're still moving through those
5	sites. We're also working with ADEM. They just
6	recently reviewed a work plan of ours concerning that.
7	And we'll be addressing their comments to that work
8	plan, shortly.
9	Within the Charlie area and
10	again, that's the Fish & Wildlife area, that's the
11	light green area over here what we've been
12	essentially doing in there is clearing roads and fire
13	breaks so that they could operate off the roads and
14	fire breaks. That's in the areas where we know we've
15	got ordnance from the draft document that we've got
16	out now.
17	And I'll tell you, the State has not
18	seen that document. We're still working it,
19	internally. We're also working it with
20	Fish & Wildlife.
21	But we are clearing the roads and
22	fire breaks so that they can operate, particularly

since they need to do prescribed burning. And the way

23

1	that they do that in those areas is to work off those
2	roads that they know are clear. So, that's still
3	ongoing.
4	Within the eastern bypass and
5	I'll point out, this particular map here this is
6	the eastern bypass, there is three sections
7	essentially to it, and they're identified in different
8	means. This is called tract one, tract
9	(demonstrating) three and tract two, tract two
10	being the flying J., we've already transferred that.
11	We have some ongoing issues with ADEM on actually,
12	on a lot of the UXO stuff, but we're working through
13	them as best we can.
14	But the area that we have completed
15	clearance on is this portion (demonstrating) of
16	tract three, this piece has been cleared together up
17	here, part of the tract two and the tract three. We
18	have submitted a removal report to the State, to ADEM.
19	I know it's still in review. Shana, right?
20	MS. SHANA DECKER: Which one?
21	MR. RON LEVY: For the eastern
22	bypass, tract three or OE area two?
23	MS. SHANA DECKER: It's

1	MR. JIM GRASSIANO: That's correct.
2	Yeah, it should be coming pretty soon, as far as I
3	understand, very shortly.
4	MS. SHANA DECKER: Yeah.
5	MR. RON LEVY: The Army did
6	internally conclude its clearance and has signed a
7	statement of clearance. Since the time of this, we
8	have signed a statement of clearance on it, and I
9	think we're going to be working for right of entry to
10	ALDOT.
11	There are some pieces in there that
12	are not clear, that are cut-outs along the eastern
13	(demonstrating) boundary, there is about four acres
14	in there that are there is some lead issues, some
15	ranges, we're working to try to address that, maybe in
16	a separate cleanup. Haven't really gotten there, but
17	it's not part of a planned (inaudible), working on it
18	right now.
19	Training area, T-38, on this map
20	(pointing) I don't think it points it out,
21	directly, but T-38 is right here. (Demonstrating.)
22	T-38 is an area that we were removing what was known
23	as 3X material. 3X material is that material that was

1	once used for chemical agent training, may have been
2	contaminated with agent, and was subsequently
3	decontaminated with agent.
4	The Army's view of that material is
5	that it needs to be disposed of, properly. So, we
6	were in the process of digging up that 3X material.
7	During that process, we came across a vial of diluted
8	mustard used in what they called case kits. We had to
9	go into an emergency role, and we destroyed that vial.
LO	In the process, we went back and
L1	looked at whether you know, what internally we
L2	intended to do with the site, whether we wanted to
L3	handle it internally as a CWM site, based on the vial
L4	we found, or whether, because of safety requirements,
L5	we were able to continue on in the role we're in,
L6	whether but increasing our safety standards in
L7	the event that we might hit another one.
L8	Right now, it's still in internal
L9	discussion with the Army, so that the work at T-38 is
20	essentially stopped. As soon as we can work out the
21	action that we need to take, to increase the safety
22	posture, we will we're in a hold pattern right now.
23	We're waiting on the Department of the Army level

1	decision, in which direction it will go.
2	T-24 Alpha, we've completed the
3	fieldwork out there. We've removed the 3X scrap,
4	disposed of all of it, all of that 3X scrap off-site,
5	so, it's pretty much a success story. 24 Alpha is in
6	the Fish & Wildlife area. This is 24 Alpha right
7	here. (Pointing.)
8	It had it was also a CWM site,
9	with a history of chemical agent training. And we dug
10	into pits out there, where the chem school or those
11	people were trained out there, after they
12	decontaminated their items, disposed of these 3X
13	items, that could be anywhere from containers to a
14	used munition of some sort.
15	MR. DWIGHT MITCHELL: Ron, can you
16	explain 3X a little better? These were items that
17	were contaminated once, but decontaminated and then
18	disposed of in the ground?
19	MR. RON LEVY: Right. It's Army
20	term, it's not a regulatory term. It's an Army term.
21	MR. DWIGHT MITCHELL: I understand,

but are those the current procedures for 3X, as

opposed to 5X?

23

1	MR. RON LEVY: Yes, there are
2	procedures for 5X, essentially stands for something
3	that's been that's help me out here, Gary.
4	MR. DAN COPELAND: Been at a certain
5	temperature for a certain amount of time.
6	MR. RON LEVY: What?
7	MR. DAN COPELAND: It has to get to
8	a certain temperature for a certain amount of time.
9	MR. RON LEVY: Yeah, it's been
10	there is no there's no possibility of an agent to
11	be in there, at all, whatsoever. It's called sterile.
12	MR. GARY HARVEY: And 5X means we
13	can't detect agent, period, with all the stuff we've
14	got. And it came out in the old days that 3X was the
15	level of reading, and it was the number of decimal
16	points to the right that you could measure to back
17	then, and those names just stuck.
18	And then you get to 5X, of course,
19	you cannot detect any agent, at all. And the way we
20	make sure of that is of course, if you can't detect
21	it, you can't detect it. And that's where
22	incineration comes in.

Those rounds were sent out to

1	Joplin, Missouri, and they were subjected to heat
2	for you know, two thousand degrees for twenty
3	minutes, or fifteen hundred for fifteen minutes,
4	depending on who you talk to.
5	MR. DWIGHT MITCHELL: So, now that
6	3X material would actually be 5X before it was
7	MR. GARY HARVEY: Yes.
8	MR. RON LEVY: Well, we ship it
9	off-site for incineration. And here's the thing about
10	the 3X material, we're not able to actually tell if
11	there's any outgassing of any agent coming off of it,
12	because we are sampling as we go. But the only way
13	the Army is to assume that it's 5X is through the
14	incineration. So, we can't say it's 5X until we
15	incinerate it.
16	MR. GARY HARVEY: But when it left
17	here, we had put it in a hot box and measured and
18	couldn't detect anything or it wouldn't have left.
19	MR. RON LEVY: Under the landfill
20	EE/CA investigations you heard some of the work
21	that's being done by the JPA for those fill areas that
22	are in their realm we're trying to complete the
23	reports on most of these. The stump dump, which is

1	still in the Fish & Wildlife area, we're in the
2	process of trying to mark that with monuments.
3	And T-38 excuse me, landfill
4	three, as Miki mentioned, they're going to be doing
5	some sampling on that. But we're trying to complete a
6	finding a report of findings. And then an area
7	that's down here, called fill area (inaudible)
8	THE COURT REPORTER: I'm sorry. An
9	area down here called what, Ron?
10	MR. RON LEVY: Fill area west of
11	Iron Mountain Road, Range 19.
12	THE COURT REPORTER: Thank you.
13	MR. RON LEVY: We're trying to
14	complete a report out there. That site essentially
15	was completely removed when they started the UXO
16	removal from the site. So, there is no there's
17	nothing left in the site. And we are we're going
18	to work to submit a report on that effect.
19	Finding of suitability for transfer,
20	Highway 21. It doesn't show here, but essentially,
21	the property underneath Highway 21 from here

(pointing) -- toward -- to the end of the installation

22

23

was Army property.

1	And I guess we provided the
2	Department of Transportation the right-of-way when
3	they built it, so, we needed to transfer it. We
4	didn't realize at the time we initially started our
5	investigations or our baseline survey that it was Army
6	property. As we started to look hard at the records,
7	we discovered it was Army property. So, we needed to
8	deed the property.
9	There is a ten-acre piece up in the
10	north, which is impacted by the plume from landfill
11	three, about this (demonstrating) this wide,
12	that the Army owns. It's not part of that finding of
13	suitability transfer and will stay until the
14	completion of the remedy up there, and so, that we
15	can transfer it, as well.
16	So, the Highway 21 FOST, which is
17	for those of you who don't know, a FOST is Finding of
18	Suitability Transfer. It's a document, essentially
19	documents the condition of the property if it's
20	suitable to transfer to the community. And then
21	following that, we with all the approvals, we issue
22	a deed.
23	And then the eastern bypass tract

- three, we're working -- presently working a FOST for
- that. It's not gone to the regulatory agencies.
- 3 That's this piece again -- (demonstrating). But we're
- 4 working that with the understanding that we have
- 5 completed the removal action there.
- 6 Other property transfers are listed
- 7 there. We did get signing of the deed for tract two,
- 8 and the western portion of tract three that went to
- 9 ALDOT. That's this piece and this piece right here.
- 10 (Demonstrating.)
- 11 And then there was building 228,
- which for some reason, took awhile to get transferred.
- 13 And it's a building -- it should be this building
- 14 right here. (Pointing.) It's in the warehouse area.
- 15 And it went for -- to the fire department, Gary?
- 16 MR. GARY HARVEY: Fire department
- 17 under a FEMA public benefit conveyance.
- 18 MR. RON LEVY: And that's it, in
- 19 terms of work that's been going on, things that have
- 20 been done. Anybody got any questions?
- 21 MR. DAVID STEFFY: Yeah, I got one.
- 22 Your work -- you had more work with UXOs. Are you
- going to be addressing the issues brought up by his

1 report about QA/QC and UXO	work?

- 2 MR. RON LEVY: Directly with the
- 3 State. In fact, yes, we're in discussion with the
- 4 State about that. The QA/QC is a specific issue the
- 5 State has with us. In fact, several of their letters
- 6 that were pointed out in the TOSC and have directed
- 7 some questions at us about that. I don't know if
- 8 Huntsville wants to talk about that, at all, at this
- 9 point, but we do need to address it.
- 10 MR. DAVID STEFFY: Could it affect
- 11 property already transferred?
- MR. RON LEVY: I think that the
- 13 State has some issues with property that's already
- 14 been transferred, as it relates to that. Am I correct
- on that, Jim?
- 16 MR. JIM GRASSIANO: I'm sorry. I
- 17 was --
- 18 MR. RON LEVY: Particularly, the
- 19 tract two piece, they still have some questions about
- it on property that's already been transferred, the QA
- 21 process.
- 22 MR. JIM GRASSIANO: We do. The
- 23 terminology changes a little bit. And I can't see

- MR. JIM GRASSIANO: OES 1.

1	MS. SUSANNE MURDOCK: OES 1.
2	MR. JIM GRASSIANO: Okay. That is
3	still under review and that ADEM review is coming on
4	that.
5	MR. RON LEVY: I really haven't seen
6	their comments, but we expect that they're going to
7	that they're going to we've been talking about it,
8	that they're going to take some issue with that.
9	MR. JIM GRASSIANO: Our comments on
10	that are going to be, to my understanding, very
11	similar to the comments on the flying J., which would
12	make sense, they were done pretty much in conjunction
13	with each other, as far as I understand, is how the
14	work was done, which that shouldn't be any surprise.
15	MR. RON LEVY: We believe that there
16	is a QA process that we could show them that's
17	internal. We've in fact showed them you guys, you
18	want to add to that, Dan?
19	MR. DAN COPELAND: (Shakes head.)
20	No. You asking a question?
21	MR. RON LEVY: I'm asking a

question. Have you got something to add to that, is

22

what I just said?

1	MR. DAN COPELAND: No, I was just
2	agreeing with him that the flying J. and the western
3	portion of tract three, were encompass (phonetic)
4	the same time.
5	MR. DAVID STEFFY: If you change
6	your QA procedure, does that mean you would have to
7	redo that land that you already transferred?
8	MR. RON LEVY: That's not our plan,
9	at this point. We probably need to delve into the
10	process that we used with them, but, no, we believe
11	that it's clean.
12	MR. DAVID STEFFY: And that's up for
13	you and ADEM to agree on?
14	MR. RON LEVY: Certainly, it's
15	something that ADEM and the Army will have to come to
16	agreement on.
17	MR. DAVID STEFFY: So, there's no
18	property that JP oh, she left that JPA has that
19	could be involved in this now?
20	MR. RON LEVY: Well, the issue still
21	is the Bravo area, but the cleanup is still ongoing on
22	it, or the characterization is ongoing, so, the Army
23	has still got the cleanup. We've transferred the

Т	property, we transferred on an early transfer, but
2	we're still responsible for cleanup, hence, we're
3	still responsible for the issues that are associated
4	with the State now (phonetic).
5	MR. JIM GRASSIANO: That's a good
6	question. There were issues with the Alpha area, as
7	far as what additional work needed to be done. And
8	actually, I think JPA is very aware of and the Army
9	is there is a meeting of the minds, if you will, on
10	the additional work that needs to be done in the Alpha
11	area, and that's the project that JPA is right now
12	I don't want to speak out of turn for them, but it
13	will help in the context of your question they have
14	a RFP out to UXO contractors to conduct that
15	additional work in the Alpha area right now. My
16	understanding is, they're a couple of weeks away from
17	selecting a contractor to do that work.
18	MR. RON LEVY: We provided to the
19	JPA additional funds for characterization on the areas
20	that the State and the Army didn't agree that they
21	were fully characterized. So, we didn't within the
22	ESCA, they have money to do additional
23	characterizations for those sites, for those pieces

1	within the Alpha area, that they couldn't come to
2	agreement that they were fully characterized. That
3	funding is in place.
4	In addition to that funding, we
5	provided funding for the actual cleanup. So, the onus
6	is on the JPA to complete the characterization,
7	negotiate that with the State, and conduct the
8	cleanup.
9	MR. MONTY CLENDENIN: Okay.
10	Anything else, Ron?
11	MR. RON LEVY: Not unless anybody
12	has got anymore questions.
13	MR. MONTY CLENDENIN: Anymore
14	questions?
15	MR. PETE CONROY: Quick one. I know
16	recently the JPA, Fish & Wildlife Service met with
17	regards to the age-old issue of opening up Baines Gap.
18	And was Army involved with that meeting or was that

22 I'm sure. I understand an outcome of that meeting was

- 13 Anything else for Ron? Let's move on then.
- 14 TAPP report, anything from --
- 15 MR. RON GRANT: No, nothing
- 16 assigned, nothing accomplished.
- 17 MR. MONTY CLENDENIN: How about the
- 18 TOSC report, who is doing that?
- 19 MR. BOB SCHMITTER: We're done.
- MR. MONTY CLENDENIN: You're done,
- 21 okay. Upcoming programs.
- 22 MR. PETE CONROY: I think I wanted
- 23 to go backwards just a little bit. We missed the EPA

- 1 report, and obviously there's no one here from EPA.
- 2 And I just wanted to get a status as to EPA's
- 3 involvement. Anybody know?
- 4 MR. MONTY CLENDENIN: I don't know.
- 5 MR. GARY HARVEY: Involvement in
- 6 what?
- 7 MR. PETE CONROY: This meeting in
- 8 particular, the RAB.
- 9 MR. RON LEVY: Well, I'll tell you
- 10 this, Pete, that, you know, we notified EPA just like
- everybody else that the RAB is in session and when
- it's in session. They get the same notification, we
- 13 ask them to attend.
- I know that EPA's also got some
- 15 travel restrictions associated with what they're
- doing, and that's about all I know about it.
- MR. PETE CONROY: My hunch is you're
- 18 right, it's a travel-restriction issue. I was just
- 19 wondering if there was anything more official or
- 20 more --
- MR. RON LEVY: No, and I haven't
- heard anything new.
- 23 MR. GARY HARVEY: He called and said

1	he had another he was on another job, right?
2	MR. RON LEVY: He said he was going
3	down to Florida for another job, but that was a
4	voice mail that I got from him, essentially. I didn't
5	talk to him personally about it.

8	selfish point of view if that's a good answer, that

20	view, to have them involved in this process? If so,
21	maybe we ought to remind them of that.
22	MR. JIM GRASSIANO: I mean, they

receive the documents that ADEM receives, and I

1	understand they're still reviewing them at least
2	the Army generated documents, which has been
3	99 percent of the documents that are heretofore
4	transmitted. So, yeah, I would expect they should be.
5	MR. PETE CONROY: And I guess my
6	point is: Unless we say that we missed them and we
7	would like them to come to the next meeting, I bet
8	they won't.
9	MR. RON LEVY: And I think that's
10	something you had pointed out previous years back.
11	MR. PETE CONROY: Yeah, and when we
12	wrote a letter, they started coming again. And I was
13	told by the Army and ADEM that they contributed.
14	MR. RON LEVY: They definitely are
15	still part of the process.
16	MR. GARY HARVEY: They still attend
17	and participate in BCT meetings.
18	MR. PETE CONROY: Good question.
