4	MR. TODD BIGGS: Todd Biggs,

6	MS. KAREN PINSON: Karen Pinson,
7	Fort McClellan, Transition Force.
8	MR. MARK STARNES: Good afternoon,
9	Mark Starnes with Western Solutions.
10	MR. LABARRON RUDOLPH: LaBarron
11	Rudolph with ADEM.
12	MS. TRACY PEACE: Tracy Peace, ADEM.
13	MR. RON GRANT: Ron Grant, TAPP
14	contractor.
15	DR. DAVID STEFFY: Thank you.
16	Since we do have a quorum, we'd like
17	to ask for approval of the minutes from April of 2005,
18	which are attached for you. So, please, take a minute
19	to review.
20	ED KIMBROUGH: Make a motion for
21	adoption.
22	DR. DAVID STEFFY: Do I hear a

23 second?

1	MR. JIM MILLER: I second.
2	MR. CURTIS FRANKLIN: Second
3	MR. JIM MILLER: I yield.
4	MR. CURTIS FRANKLIN: I defer to
5	him.
6	DR. DAVID STEFFY: Any yeas? And
7	any nays? Motion for the agenda to be accepted.
8	New business agency reports, ADEM?
9	MS. SHANA DECKER: Yes?
10	DR. DAVID STEFFY: Yes.
11	MS. SHANA DECKER: You're ready,
12	already?
13	DR. DAVID STEFFY: Yeah.
14	MS. SHANA DECKER: Well, this
15	quarter, first of all, I want to introduce our new
16	chief of engineering services section B we've been
17	split into two sections, in case anybody was
18	wondering is Tracy Peace. She's sitting right over
19	here, new chief of engineering section services and
20	also, our new tier two representative for
21	Fort McClellan.
22	This quarter, we've been
23	concentrating on completing document reviews for the

1	upcoming ESCA negotiations between JPA and the Army,
2	been doing several documents, including things like
3	the stump dump and the impact area south of the
4	prisoner of war training facility and some others and
5	Bravo EE/CA stuff. Anyway, so we've been trying to
6	catch up on a lot of some backlogged review
7	documents.
8	Also, this quarter we've issued a
9	letter which describes our understanding of the
10	what we came to decide in the M-101 and the M-3 and
11	the Y area, which was the Army and JPA were to come up
12	with a construction support, what level of
13	construction support they were going to provide in
14	that area.
15	I don't know if y'all remember, but
16	last quarter we had done additional investigation and
17	discovered some more, just training items that didn't
18	redefine the area, but it did we did decide that it
19	warranted further construction support, which is what
20	we all agreed to in that during this quarter.
21	Also, during this quarter, ADEM has
22	brought on board an UXO contractor and an
23	environmental services contractor. Our UXO contractor

1	is Mr. Jim Pastoric (phonetic) of UXO Pro. He's out
2	of Alexandria, Virginia and is providing review
3	services for us, as far as UXO is concerned, and also
4	he's been coming out here and providing some oversight
5	at the Eastern Bypass construction debris removal and
6	anything else that we get started on here in the near
7	future.
8	And also yes, and it's to cover
9	both the JPA and the Army. He also provided oversight
10	for the Alpha area, supplemental EE/CA investigation
11	that was just completed in the Alpha area.
12	Also, we have on board a contractor
13	called TRC, who are out of Lola, Massachusetts, which
14	is up there by Boston. And they have provided us with
15	a lot of comments on Bains Gap Road investigation and
16	the landfill and fill area EE/CA, and also
17	Bains Gap Road RI investigation, all of which were
18	some very substantial investigations. So, we were
19	very happy to have their help.
20	They also provided us with some
21	expertise that we didn't necessarily have, such as
22	some really intensive risk assessment for these ranges
23	and wells with the critters living on them. And so,

1	this	was	а	lot	of	expertise	that	we	really	welcomed	at

- 2 ADEM, so we're happy about that.
- 3 Like I said, we've been out here.
- 4 This quarter, we've provided field oversight with JPA
- for the Alpha area EE/CA, the supplemental EE/CA,
- 6 which they did find some interesting items and were
- 7 able to more better define clearance areas in that
- 8 area. That's what they were put on now, I believe.
- 9 And also, we went on tour with the
- 10 EPA, which brought us all to the ranges. I think
- 11 small arms ranges is what we all saw that day.
- MR. RON LEVY: Yeah.
- 13 MS. SHANA DECKER: And we went into
- 14 Choccolocco corridor and the Charlie area and Bravo.
- And we also had another tour with
- 16 our new contractor, John Pastoric, and saw a lot of
- 17 the UXO ranges, which was another day we spent up
- 18 here.
- 19 Right now we're working on the MOA
- 20 with the Army, the memorandum of agreement, and we're
- 21 updating that, and the clean-up agreement with JPA,
- 22 all this is for the forthcoming, upcoming ESCA
- 23 negotiations that they have to go through. So, that's

1	what	we're	working	on	right	now.

- 2 That's about it. Any questions?
- DR. DAVID STEFFY: Any questions?
- 4 Thank you.
- 5 The next agency is EPA. Do they
- 6 have a rep here? No, okay.
- 7 On to the JPA.
- 8 MR. GREG SCHANK: During this last
- 9 quarter, we completed some additional characterization
- 10 at the T-38 training area. We installed a few
- 11 additional wells and sampled existing wells, plus the
- new wells, some surface water samples and some seep
- 13 samples.
- 14 The Alpha area fieldwork is
- 15 complete. The report is currently in preparation. We
- did find a few items out there that had to be blown in
- 17 place. Most notably, I think a forty millimeter HE
- 18 round grenade.
- 19 (Whereupon, Joe McCary enters the room.)
- 20 MR. GREG SCHANK: Some upcoming
- work, we're going to do some additional
- 22 characterization on the T-6 training area. I expect
- that to start next month.

1	Bains Gap Road, we have written an
2	action memorandum to send in. ADEM has reviewed that
3	and commented on it. So, we're going to try and
4	finalize that.
5	We're also going to try and have a
6	UXO contractor on staff hopefully sometime by the end
7	of August. They will have to do an explosive safety
8	submission to the DDESB, that's a safety board. And
9	that has to be approved before we can start doing
10	clearances along Bains Gap Road, but that is moving
11	forward, and we do expect to be out and working in
12	that area this calendar year.
13	That's pretty much it. I guess you
14	know that the sale of the commissary to Box Car fell
15	through. I'm not exactly sure of why that happened.
16	There are some additional properties
17	out here that the JPA is currently marketing. And I
18	don't know all of them, but every day I get requests
19	for information on different areas.
20	And that's pretty much it. Does
21	anyone have any questions?
22	MR. ED KIMBROUGH: The
23	status on Bains Gap, has their Wildlife has there

- to meet the standards? 2.
- 3 MR. RON LEVY: I can probably talk a
- little bit about that.
- MR. GREG SCHANK: Yeah, I can't
- 6 speak for the Wildlife people.
- MR. ED KIMBROUGH: Okay. Well, I
- mean, y'all going to do y'all's? The JPA is going to 8
- 9 do theirs?
- 10 MR. GREG SCHANK: We'll do Alpha and
- Bravo. 11
- 12 MR. ED KIMBROUGH: And then that
- will clear it up to Wildlife? 13
- 14 MR. GREG SCHANK: Yes, sir.
- 15 MR. ED KIMBROUGH: And then the
- 16 Wildlife can --
- MR. RON LEVY: Yeah. And I'm going 17
- to talk a little bit about it when I get into the 18
- 19 action summary --
- MR. ED KIMBROUGH: Okay. 20
- MR. RON LEVY: -- if you want to 21
- 22 wait.
- 23 MR. ED KIMBROUGH: Okay.

- 1 That will be fine.
- 2. MR. GREG SCHANK: Any other
- 3 questions?
- DR. DAVID STEFFY: Before we
- 5 proceed, I would like to, for the record, mention that
- Joe McCary has come in to join us. And now on to the
- action summary sheet.
- 8 MR. RON LEVY: Let me get Brenda to
- 9 bring up this map to orient you. I know we've got a
- 10 couple of new members here that probably don't have a
- full feel for where these sites are and I wanted to be 11
- able to point them out to you as we went along. 12
- For those of you who are new, when 13
- 14 we started the cleanup, we portioned the property
- 15 based upon priorities, particularly what was important
- to the JPA, and there was -- from a MEC standpoint --16
- 17 that's the cleanup of unexploded ordnance -- there was
- three specific areas that we identified. 18
- The priority one at the time when we 19
- started this was called Alpha area. It's this orangy 20
- 21 color. And it was the primary focus.
- 22 The other two areas is this light
- 23 blue area, which is called the Bravo area; and the

- 1 green area, which is called the Charlie area, which is
- 2 mostly associated with the Fish & Wildlife portion,
- 3 that part that's become part of the
- 4 National Wildlife Refuge.
- 5 Within the priority area there are
- 6 some other pieces up here, the M-101, M-3, golden
- 7 triangle area that you've heard Shana talk a little
- 8 bit about. And that's essentially how the cleanup
- 9 looks from a MEC standpoint. The Eastern Bypass is
- shown here, along the western boundary of the
- 11 installation.
- 12 We also have sites associated with
- what we call HTRW, that's everything else besides UXO
- or munitions cleanup. You know, it's groundwater
- 15 contamination, soils, and other contaminants that
- we're trying to address.
- 17 But let me start out with the Brayo
- 18 area. There is about three thousand, three hundred
- 19 and twenty-seven acres of land that we've been working
- on. We conducted what was known as a Bravo
- 21 engineering evaluation characterization. The document
- 22 went through several iterations.
- 23 It's presently been submitted to

1	ADEM as of December 2004. ADEM came back to us with
2	comments on that document. There was some significant
3	comments associated with the document, related to the
4	areas we defined for no further action. We're still
5	in the process of addressing those comments and
6	getting that back to ADEM.
7	There is another piece that they're
8	still looking at, which involves those areas where we
9	defined some level of cleanup, based on a reuse.
10	That document, as we briefed before
11	to this RAB, for those of you who are new members who
12	are interested in hearing some more about that, I can
13	provide that to you. If you want to get with me
14	off-line, I can certainly show you with the slides or
15	whatnot that are associated with that.
16	Within the Bravo areas is also the Y
17	area junction, which is again, this little area right
18	here. And that, along with an area called M-3 and
19	M-101, up in this area represented here we did a
20	clear to depth in this Y area, and we did a surface
21	removal up here. Based on what we found, we
22	determined it to be clear.

We went through some iterations with

23

1	ADEM about the clearance and the level of removal.
2	And we concluded, based on discussions, that we would
3	provide additional support during time of construction
4	for both of these areas, and we would do that, as
5	Shana pointed out, through the Environmental Services
6	Cooperative Agreement. That's the documents, or the
7	action that's presently being worked with the JPA to
8	provide funding for them to conduct cleanup on the
9	post.
10	In the Charlie area here, we did
11	complete an EE/CA for that document excuse me
12	for that area. It was submitted back in December
13	to ADEM and to Fish & Wildlife well, in February,
14	February the year before. We had comments from
15	Fish & Wildlife that we're in the process of
16	addressing, and we're still waiting on ADEM's
17	comments. So, it's not a priority from the standpoint
18	of ADEM's workload, in terms of what we gave them.
19	One of the things we also did in
20	this area is we cleared the roads and firebreaks. The
21	intent there was to allow Fish & Wildlife to work off
22	the roads and firebreaks so they could do their
23	prescribed burns for maintenance of the long-leaf

- 1 pine. So, that's been concluded.
- 2. And that report has been sent -- has
- 3 been sent up -- excuse me. I stand corrected. That
- 4 report is still underway. We have not sent that up,
- 5 yet.
- Eastern Bypass, again, it's this
- 7 piece that's located on the western periphery of the
- installation. There was three different tracts. 8
- 9 Tract one was located in the southern portion, and you
- 10 can't really see it, because it's not mapped out here.
- But if you look at this map over 11
- here over Mr. Jackson's right shoulder, you'll see 12
- this area down in here is tract one. And then tract 13
- 14 two was the northern piece up here. It was the --
- 15 this Y -- excuse me -- this flying J, a piece of the
- top part of the Eastern Bypass up here. And then 16
- 17 tract three was this piece in here.
- The status of that is: Tract one 18
- has been transferred, transferred to the 19
- 20 Alabama Department of Transportation as part of the
- 21 Eastern Bypass. Tract two, that's been transferred to
- 22 ALDOT, and we've conducted the clearance on that,
- 23 already.

1	And then tract three is still
2	undergoing a level of clearance. We did an EE/CA and
3	a removal on tract three. We did a clearance to
4	depth. However, there was some acreage within the
5	tract three that, based upon what was there, a lot of
6	construction debris, geophysically, we weren't able to
7	see below.
8	At the time we did the clearance, it
9	was decided that, well, because we were going to build
10	the highway over the top of it, it really shouldn't
11	present a problem. So then, as we went into
12	negotiations with ALDOT and ADEM, it was determined
13	that we needed to go back in and at least clear that
14	portion that was four feet that would require four
15	feet or less of fill.
16	Right now, the Army's working on
17	that site, doing the removal. At the present time,
18	they're in the field. In fact the work began on the
19	31st of May, and we expect to complete that when,
20	Todd, the fieldwork?
21	MR. TODD BIGGS: End of August.
22	MR. RON LEVY: End of August.
23	The M-101 and miscellaneous parcels

1	in here,	we have	negotiated	with	ADEM	and	the	JPA	for

- 2 some funding to provide construction support. And
- 3 that's still being worked as part of this upcoming
- 4 ESCA or modification of the upcoming ESCA.
- 5 Let's see, can you bring up the ESCA
- 6 map, ACES map? Now, this is going to be a little hard
- 7 to see, but it tries to lay out the property that is
- 8 going to the JPA for clearance. As I mentioned to
- 9 you, for the most part, all this in the Alpha area,
- 10 all these sites up in through here, are now part of a
- 11 cooperative agreement with the Army between the JPA
- 12 and the Army for clearance.
- Greg pointed out some of the
- 14 clearance levels in there. There has been some
- ongoing negotiation, we expect to conclude soon, for
- 16 some additional pieces that we're going to pay the JPA
- 17 to do. One is this area in here. It's called
- 18 planning area four. And it's a MEC and lead removal
- 19 area.
- 20 It's a priority area for the JPA for
- 21 purposes of development. They've got a research area
- defined for that at the present time.
- 23 And the other was

20

1	Iron Mountain Road, right through here, to do a
2	clearance up and down along Iron Mountain Road as part
3	of this industrial access road that will go around the

- 4 old Cantonment area and come out at the top up here on
- 5 21, which, as it stands now, is defined for clearance
- based on what we've discovered in this area.
- So we're providing or we're
- 8 attempting to provide funds for that particular
- 9 clearance.

- 10 There are other pieces that we're 11 doing. I talked about the construction support for the golden triangle that we're giving to the JPA, the 12 industrial access road, then there's the -- the south 13 14 part of Bains Gap Road, this is -- let me see if I can get this right. This is Bains Gap Road, here, and 15 it's been an issue about clearance for access to the 16 17 general public. You heard Monty talk about that. You
- 19 What we've essentially done is: 20 We've provided funding for the JPA to clear along the 21 side of the -- the road, and along side of the road 22 for both the south and the -- excuse me -- both the

- 2 On top of that, which is not part of
- 3 the ESCA, we have agreed to provide funding to do
- 4 clearance of the rest of Bains Gap Road that runs
- 5 through the Fish & Wildlife area. What
- 6 Fish & Wildlife has told us is that they're going to
- 7 need at least a hundred foot on either side of the
- 8 center line.
- 9 So, we're working funding right now,
- 10 and the Army has already committed to that. There was
- 11 a letter that went out to the County -- I don't know
- 12 what the date was on it, but the Army has already said
- we commit to doing that clearance.
- MR. ED KIMBROUGH: Are those new
- 15 funds?
- MR. RON LEVY: New funds, right.
- 17 These aren't the County's funds.
- 18 Now, the County has committed or
- 19 will commit to some funds that they've got with the
- 20 CCEP program to give to Fish & Wildlife to do some
- 21 expansion and improvements to the road. Those are
- 22 different funds than what the Army is going to provide
- 23 separately to do the MEC clearance or the UXO

1	clearance on the road. Does that make sense to you?
2	MR. ED KIMBROUGH: So, what kind of
3	timeline are we looking at there?
4	MR. RON LEVY: I think it comes I
5	don't know what the timelines are. It comes down
6	to I know that Fish & Wildlife has to do A
7	compatibility determination, they have to do some
8	design work, a survey and then some design work on the
9	road, so they can meet the federal highway standards,
10	but our piece should come fairly quickly. When I say
11	the Army's piece to do the clearance, because we have
12	to already we actually have already done some
13	clearance on the road, and then we'll continue to do
14	the rest of that clearance. Now, that's on the
15	Fish & Wildlife side.
16	And again, the piece that's on the
17	JPA's side, that money is in part of this
18	modification, this next modification. And did I say
19	anything wrong there, Greg, that you're aware of?
20	MR. GREG SCHANK: No. That's the
21	way I believe it's going to happen. It will still be
22	a few months. We have to go out and get a contractor

- MR. RON LEVY: And then on the
- 3 Fish & Wildlife side of the road, that funding is
- going to become available -- as an Army action, we're
- 5 going to go in there and do the clearance.
- 6 MR. ED KIMBROUGH: But that hasn't
- 7 hadn't previously been made available, is what I'm
- 8 saying?
- 9 MR. RON LEVY: That's correct. As
- 10 far as what you're telling me.
- 11 But my understanding is all of the
- 12 funding is in place to do the clearance, and it just
- 13 comes down to how long it will take to get through the
- 14 entire process of clearance, design, construct, and
- open the road, and I couldn't tell you what that's
- 16 going to take.
- 17 MR. MONTY CLENDENIN: And even after
- 18 all this, do I understand the road will be closed at
- dusk and opened at dawn?
- 20 MR. RON LEVY: That's an issue with
- 21 Fish & Wildlife.
- 22 MR. GREG SCHANK: I've been led to
- 23 believe that's true.

1	MR. MONTY CLENDENIN: That's what
2	I've heard.
3	DR. BARRY COX: Then if that's the
4	case, then how can it be used for CCEP evacuation
5	MR. GREG SCHANK: If there's an
6	emergency, the road they from what I've been
7	told, they're planning on somehow having a mechanism
8	in place that if there is an evacuation necessary,
9	they'll be able to open that road, automatically.
10	MR. RON LEVY: If necessary, it's
11	just a swing gate. It can be popped open for
12	emergency purposes and be used. I mean, I guess part
13	of Fish & Wildlife's concern is the ability to patrol
14	and be there while people are using the road, and
15	that's a problem at night, in the night time hours.
16	MR. MONTY CLENDENIN: I love
17	Gary Harvey's comment last time; he said that the Army
18	did not close the road, the Army put up a gate. I
19	thought that that's dancing real well.
20	MR. RON LEVY: Well, it's always
21	been the Army's position that if the public or the
22	JPA and the Fish & Wildlife wanted the road open, that
23	they could open it. But if you're going to expand the

- 2 MR. ED KIMBROUGH: And there wasn't
- any funding provided in that first funding to meet
- 4 that criteria.
- 5 MR. JIM MILLER: Whatever the
- 6 history of it was now it looks like it's going to be
- 7 opened from everybody's point of --
- 8 MR. RON LEVY: From the Army's
- 9 standpoint, yes. I mean, there is -- the Army is
- 10 going to provide all the funding that's necessary from
- 11 the clearance standpoint. The rest is going to fall
- 12 within the JPA and Fish & Wildlife to get their piece
- done.
- So, I view this as something that's
- going to happen. It just -- you know, what the
- timelines look like, I can't talk to you about that,
- 17 Fish & Wildlife.
- 18 MAYOR WILLIAM KIMBROUGH: Well --
- 19 and I'll shut up after this -- but it seems to me like
- 20 the Fish & Wildlife and JPA and the Army, at one time,
- 21 couldn't get together on what was being said. Now, it
- 22 seems like that communication has gotten together, and
- it's going happen.

1	MR. RON LEVY: The ESCA
2	modification I'll go on and finish up. The ESCA
3	modification, most of you are aware that the original
4	ESCA was forty-eight point five million dollars and
5	included sites within the Alpha area and other
6	extraneous sites that were associated with landfills
7	and some that were in the cantonment area.
8	We attempted in this next
9	modification to buy out any Army continuing
10	responsibilities. However, there are a few sites that
11	are still involved in Army continuing responsibilities
12	and provide additional funding for the JPA to go after
13	additional priority sites, again, planning for the
14	industrial access road, the area that they considered
15	crucial, which was what they call the golden triangle
16	area, because of the bypass coming through and wanting
17	development around there is where we focused our
18	funding on.
19	So, of the forty-eight well, the
20	forty-eight point five million, we are going to add
21	another well, a little over another six a little
22	over six million more dollars to that, once it's
23	implemented.

1	So, that's not the rest of the
2	cleanup. The plan is still to work the rest of the
3	cleanup with the JPA, pending additional funding being
4	available, which means the Bravo area down here and
5	sites down here should eventually become part of
6	either a phase two ESCA or another modification of
7	this present ESCA. Was that clear to everybody?
8	There's more detail in the action
9	summary sheet that was passed out, if you want to read
10	through that. But I can take any questions about
11	cleanup, at this point.
12	MR. ED KIMBROUGH: I don't have one
13	on that, but I got a question on this new road that
14	they're constructing. Can anybody answer, is that
15	going to be open or is it going to have to wait until
16	the bypass is constructed?
17	MR. RON LEVY: I'm sorry, which one
18	are you talking
19	MR. ED KIMBROUGH: The new road that
20	they're constructing out here.
21	MR. RON LEVY: Are you talking about
22	the
23	MR. JIM MILLER: Industrial access?

- 4 but we still have about three hundred and fourteen
- 5 acres to be transferred. Of that, what it mainly
- 6 consists of is the tract -- is the tract one portion
- 7 of the -- excuse me -- tract three portion of the
- 8 Eastern Bypass in here, some water tank sites, as you
- 9 can see them here, in purple.
- In fact, what you see in this
- 11 purplish color here is what's really left to be
- 12 transferred. And there's a piece of Highway 21 up in
