- 14 SCOTT BOLTON: Well, there's some
- other ways, too.
- Since we don't have a quorum, we can't
- 17 approve minutes. I suggest we move on until we
- 18 hopefully get a quorum.
- DR. MARY HARRINGTON: We can do
- agency reports.
- 21 SCOTT BOLTON: We can do that. So
- we'll do the agency reports.
- You guys ready?

1	BRANDI LITTLE: Sure. In your
2	packets should be three pages for the ADEM activities
3	report, and I have to admit I was gone for three
4	months on maternity leave, but here are the lists of
5	documents that we received and reviewed during that
6	time. And we've been doing pretty good getting
7	documents in and out lately. You can see our list of
8	meetings and site visits on the last page.
9	And we had Brittney Stroup left ADEM,
10	and we have replaced her with Ashley Toellner. Unless
11	anyone has any questions, that's all I've got.
12	SCOTT BOLTON: Michelle, you want to
13	go next?
14	MICHELLE KLOMP: I can do that. The
15	next page is a summary of the JPA documents received
16	over the previous quarter. It's pretty straight
17	forward. If you have any questions, I'd be happy to
18	answer them.
19	SCOTT BOLTON: You do realize we're
20	stalling time here?
21	MICHELLE KLOMP: If you'd like, I
22	can do diagrams.
23	SCOTT BOLTON: I guess I can give

1	you a summary of some of the Army's actions that have
2	been going on. In addition, we've just concluded
3	on the last page that Brandi referenced, we concluded
4	a couple of days of meetings with ADEM, the Army, and
5	our respective contractors on just a number of
6	different activities that are out there, half a dozen
7	remedial investigations.
8	It was a very productive meeting. I
9	think we resolved a lot of comments and kind of kicked
10	a tad forward. With any luck at all, we should
11	these activities really we can maybe get those
12	closed out and then move on to things like feasibility
13	studies and removal actions.
14	But as far as the written summary is
15	given, I think one of the biggest things that's
16	happened since our last RAB meeting, if you look at
17	the Bravo area, which is approximately 1327 acres, I
18	think most people probably seen it in the meeting, the
19	varying extent. We did the Army signed with JPA a
20	new ESCA. That just stands for Environmental Service
21	Corporative Agreement, and basically, it was
22	approximately \$182 million was the total. And what
23	that was, as many of you probably remember that there

1	was an ESCA signed in 2003, so some of the 182
2	billion, approximately 30 million was unfinished from
3	the first ESCA.
4	So the new ESCA, they decided what to do
5	is to combine it all into one new document rather than
6	having to tract things, like, ESCA 1 and ESCA 1 and so
7	on. Michelle and Lisa have had enough, you know,
8	trying to track just one ESCA, so that would be
9	another order of magnitude.
10	So that is the work that Matrix, JPA
11	were doing earlier on, the original ESCA has just been
12	rolled forward into the new one. So that's why I
13	know there was some initial confusion out there
14	somewhat about the different numbers that were
15	reported.
16	Basically, it's about 152 million new
17	work, 30 million of old work rolled forward, and I
18	don't remember what the initial funding was, do you
19	know, on the 152? I've heard some a varying number,
20	so it may not be accomplished just yet as to when, but
21	that's what's going on.
22	So what that basically does is that

23 takes that whole Bravo EE/CA area, 327 acres, and it

1	removes it from Army's responsibility with a few
2	exceptions. We've always got to have a few exceptions
3	just to make it a challenge. So the Army is still
4	responsible for finishing out the remedial
5	investigation to what we refer to as the Iron Mountain
6	Road ranges, which are kind of border the eastern
7	bypass, tract three, the last tract to go, and then
8	basically, everything else will fall to JPA, and I'm
9	assuming Matrix to finish everything from
10	characterization to actual remediation, as well.
11	In addition to Bravo area, there's an
12	area we refer to as the Eastern Bypass, the Iron
13	Mountain Road edition. This is an 11-acre area.
14	Essentially, what this is going to be is the exit area
15	for the it's the southern exit area onto Iron
16	Mountain Road, which will be eventually turned into
17	industrial access road; correct?
18	MICHELLE KLOMP: (Nods head.)
19	Uh-huh.
20	SCOTT BOLTON: In addition to that
21	area, there will be a service road that will go up to
22	Yahoo Lake as well, on that end.
23	There's 11 acres there. We've met with

1	ADEM on that a couple of times. They brought their
2	UXO people in, and some of them came to an agreement,
3	I think, on some additional sampling and how to go
4	forward on that.
5	What we're going to do is a stand-alone
6	desktop EE/CA for those 11 acres because the 11 acres
7	intrude into the Bravo area, but they're not part of
8	the Bravo area. We decided the cleanest way to take
9	care of it is to just do a stand-alone desktop EE/CA.
10	The data has already been out there. The sampling,
11	there might be some additional sampling. Everything
12	has already been done as to that specific area. So
13	that's underway, and we're contracting support for
14	some other portions of it.
15	The Charlie EE/CA area, 580, 600 acres
16	of land, pretty much Fish & Wildlife area, the Army
17	retains the responsibility for the clean up there, and
18	that's what we spent a lot of time on the HTRW, the
19	hazardous waste site. In other words, the Army met
20	with ADEM last week, and like I said, I think we have
21	a path forward on the remedial investigations there.
22	I'm not going to read you the other
23	pieces of it, but you can see where the some of the

1	supplemental clean up has been done, the roads,
2	firebreaks, and so forth. We've still got some
3	documents out there we're waiting on. The Fish &
4	Wildlife's comments, service comments, and depending
5	on if we ever get to see what the budget is going to
6	look like, we're operating under continuing resolution
7	authority right now, but as soon as I get a final
8	budget, I'll know what the program manager thinks.
9	I'm hoping that we can move some of the things on the
10	Fish & Wildlife, move them quicker.
11	We had programed some budget there to
12	support them and hopefully hopefully that'll work.
13	I'm optimistic it will. I haven't heard that it
14	wasn't, so I'm optimistic that it will.
15	The Eastern Bypass Tract 3, that will be
16	really the last that and the 11 acres I spoke of
17	will be the last of the bypass to be transferred, and
18	I think we're still awaiting on the comments to the
19	FOST from AL DOT.
20	Am I correct on that, Lisa?
21	LISA HOLSTEIN: Right.

in in the last hour and a half, we're still waiting on

22

SCOTT BOLTON: Unless something slid

1	their comment. We've met with AL DOT a couple of
2	times, and I think we should have that going, and ADEM
3	concurred with the FOST back in June, so right now,
4	it's not lost.
5	The water tank sites, a subject near and
6	dear to Mr. Miller's heart, all 22.95 acres
7	JIM MILLER: We ask for so little.
8	SCOTT BOLTON: That's right.
9	That's the one that we've the draft
10	FOST is up at the DA for review?
11	LISA HOLSTEIN: For signature,
12	they're already reviewed it.
13	SCOTT BOLTON: Yeah, for signature.
14	And we've had EPA concurrence and ADEM is so we're
15	awaiting. The ball is definitely in our court on this
16	one, and we have brought it to their attention that
17	we're still waiting on a response, so I think they're
18	working on it as we speak.
19	I think that's about all that I have

got. You know, we continue to work. Matrix and JPA

up some other functions, security functions, these

are picking up -- as part of the ESCA, they're picking

kind of things, land-use control functions, and we're

1	working with them as far as the handoff goes,
2	requesting bids and so on, and so we're going to
3	continue business as usual until they've got their
4	system in place, and we'll hand it off to them.
5	JIM MILLER: Can I ask a question?
6	SCOTT BOLTON: Sure.
7	JIM MILLER: I guess we've been at
8	the clean up, now about seven years, six?
9	SCOTT BOLTON: We've been at the
10	process seven years, yes, sir.
11	JIM MILLER: And I know that you
12	probably won't know the answer to this, but you
13	probably got a good idea or a wild guess how long are
14	we going to be at clean up before all the property is
15	transferred or we're done transferring?
16	SCOTT BOLTON: Michelle may be a
17	better candidate to answer to I'll dump this to
18	Michelle. Michelle might be the person to give you a
19	better answer on the Bravo piece of things. Okay.
20	The Fish & Wildlife piece of the refuge,
21	because of the magnitude of the UXO, and you know,
22	that's like it's like peeling an onion sometimes.
23	You've got to peel the first layer off before you can

1	get to another one so some of the more conventional
2	hazardous-waste type remediation, we can't do until we
3	get into the impact areas and take care of that. So
4	you get into a nut roll there, the sheer magnitude of
5	the clean up there. I don't recall there was an
6	agreement, and there was time lines in that in the MOA
7	between the Army and the Fish & Wildlife.
8	JIM MILLER: Are we talking 10
9	years, 15 years?
10	LISA HOLSTEIN: There weren't time
11	lines. It's just a function of findings.
12	JIM MILLER: Ball park.
13	SCOTT BOLTON: If they keep funding
14	us like they did this year, it's going to be a long
15	long time, but we had some other money we reprogrammed
16	from other areas, it could be as long as five to ten
17	years on the Fish & Wildlife piece of things.
18	JIM MILLER: I guess I misunderstood

1	SCOTT BOLTON: Well, there was a
2	little bit of that, and then subsequently, once the
3	Fish & Wildlife Service got in there, they felt like
4	they needed some changes, and so ultimately, it didn't
5	go to the resolution is when the Army had
6	JIM MILLER: So they didn't take it
7	as is, where is?
8	SCOTT BOLTON: No. The enabling
9	legislation of Steve Miller and I, we go around and
10	around about it. He's a good guy to work with, and he
11	doesn't miss many opportunities to push my buttons and
12	vice, versa. And originally, we had figured on the
13	roads and trails and fire breaks to call that clean up
14	complete, and some of the high-use areas. And then,
15	as they actually got into the refuge management or
16	refuge part of it and started looking at it, things
17	changed, so they came back to the Army.
18	And if you recall, the establishment of
19	the refuge, the way it occurred, is basically
20	Senator Sessions added to one of the Defense of
21	Procreation the requirement that DOI accept the
22	refuge, and I don't know that DOI was particularly
23	prepared at that time to do it, so that created a set

1 of	problems.

- JIM MILLER: A lot to manage and no
- 3 more resources to do it with.
- 4 SCOTT BOLTON: Yeah. I guess it's
- 5 probably not the first time it's happened with them,
- 6 but I mean, Nationwide, I think it's something of the
- issue that they're facing, the Department of Interior,
- 8 all of our Fish & Wildlife Park Service, all of their
- 9 sub-element field I guess are facing shrinking budgets
- 10 from what I understand. It's just stuff for them to
- 11 take on more. I know their personnel here are
- 12 stretched across a couple of roads. I think the both
- 13 their law enforcement services -- I think Steve is
- 14 managing Cahaba as well as --
- DR. JOHN SPAIN: Here we go.
- 16 SCOTT BOLTON: We can do something
- 17 now. Please let the record show that Mr. Franklin is
- here, and we now have a quorum.
- 19 ROBERT JACKSON: Did I understand
- you to say that all of that has to be cleaned up
- 21 before anything else can be --
- 22 SCOTT BOLTON: Not all of it. There
- are different parts of it that have different levels

1	of clean up, and I cannot recall off the top of my
2	head how much of what. I mean, it's mapped out as far
3	as X number of acres for clearance to depth or so many
4	of surface clearance and so on.
5	I mean, overwhelming in terms of just
6	sheer acreage, probably the vast majority of acreage
7	is likely to be, you know, just something like surface
8	clearance or nothing at all, but nonetheless, it
9	doesn't take much, particularly on steep elevations to
10	rachet the price tag up very quickly. It's very
11	difficult to clean on elevations, and we've got, what,
12	three Nos. 3 and 4 highest points in the state, I
13	think, on the ridge lines here, Cheaha South, and
14	Dugger Mountain North. It's not real surprising.
15	As far as the contenement area and the
16	Bravo area, that'll be JPA and, of course, Matrix.
17	They're the current operator on that. I don't know
18	what their timelines are on that.
19	Have you even had a chance to
20	MICHELLE KLOMP: We're looking at
21	about 10 years out, and typical 30 years of monitoring
22	the places. It'll be a while.

JIM MILLER: Just as long as y'all

23

1	have	aot	something	to	do.

- 2 MICHELLE KLOMP: We're keeping busy
- 3 especially at the ESCA.
- 4 SCOTT BOLTON: And the weather has
- 5 been pretty supportive, too, working in the field.

- JEROME ELSER: Speaking of the
- 21 drought, are we okay with Coldwater Springs?
- JIM MILLER: For now.

1	JIM MILLER: That's my stock answer.
2	SCOTT BOLTON: We were up in the
3	mountains on motorcycles this weekend and the
4	reservoirs and lakes and rivers are unreal, and we're
5	down probably four or five feet below normal winter
6	pool. I think, we're at, like 564 is normal winter
7	pool, and I think we're, like, 557.
8	JIM MILLER: Depending on how it
9	winds up, it's either the driest or second driest year
10	in the last hundred years.
