



**Summary of Draft EIS Public Review Process and Comments Received on the Draft EIS**

The draft environmental impact statement (EIS) for the update of the Master Water Control Manual (Master WCM) and the water supply storage assessment for the ACF Basin was filed with the U.S. Environmental Protection Agency (EPA) on September 23, 2015, and formally released for public review on October 2, 2015, when the notice of availability of the EIS was published by EPA in the *Federal Register*. The comment period was initially scheduled to be open for 60 days, ending on December 1, 2015. The U.S. Army Corps of Engineers (USACE), however, received multiple requests to extend the comment period. In response to those requests, USACE extended the comment period until January 15, 2016, providing a total of 105 days for agency and public comment.

During the comment period, USACE held public meetings on the draft EIS and Master WCM update in five cities within the ACF Basin. The public meeting locations and dates were as follows: Gainesville, Georgia, on October 26, 2015; West Point, Georgia, on October 27, 2015; Eufaula, Alabama, on October 28, 2015; Bainbridge, Georgia, on October 29, 2015; and Eastpoint, Florida, on November 9, 2015. At the open-house style meetings, technical experts were available to answer questions and discuss concerns from agencies and members of the public in an informal setting, and administrative staff registered attendees and received their comments. A total of 301 people attended the meetings, either as representatives of government agencies or private organizations or as interested individuals. Table C-1 summarizes public meeting participation, including the number of comments submitted at the meeting in written form and through a court reporter.

Additionally, numerous comments were submitted by elected officials; regional and local government agencies; businesses; environmental organizations; advocacy organizations for recreation, hydropower, navigation, and other specific interests; and individuals with an interest in USACE project operations in the ACF Basin.

Table C-2 presents a complete summary of the comments received on the draft EIS. The comments are identified essentially in the order in which they were received. The table includes the assigned comment number, the means by which the comment was submitted (e.g., letter, court reporter transcript), the author or signatory and title (as appropriate), the author's organization, the organization type, and the page number in appendix C where the comment letter and side-by-side USACE response can be found.

Upon receipt of the public comment submittals (e.g., letter, email, court reporter transcript), the project team reviewed and parsed each document into a series of individual comments by interest/concern or specific recommendation from the author (e.g., water quality, recreation, hydropower, National Environmental Policy Act procedure, cumulative impacts). Each individual comment was assigned a unique alpha character identifier corresponding to the order in which the comment appeared in the submittal. The project team prepared a response to each individual comment, specifically noting if any EIS revisions were necessary in conjunction with the response. Consideration of public and agency comments on the draft EIS led to incorporating a number of updates and revisions into the final EIS.

For easy reference, USACE responses to individual issues, concerns, and recommendations expressed in each comment submittal are presented to the right of the associated comment. Personal contact information of individuals commenting on the draft EIS was redacted from the comment-response documentation in Appendix C.
