BASIC CAMPGROUND RULES

The Corps of Engineers welcomes you to our campgrounds at Allatoona Lake. In order to make everyone's stay a pleasurable one, listed here are some of the basic campground rules derived from TITLE 36 CFR (Code of Regulations).

- CAMPSITE OCCUPANCY is limited to eight (8) people per campsite including visitors (six years of age or older). Persons camping under eighteen (18) years of age must be accompanied by an adult. Children may not be left unattended in the campground without adult supervision.
- CAMPING EQUIPMENT must be set up on gravel impact area or pavement.
- 3. VEHICLES ON CAMPSITES are limited to a maximum number of three (3) vehicles per campsite, other than camping equipment. Vehicles must be registered at the gatehouse. This includes visitor vehicles.
- 4. CHECK-IN TIME is 4 PM. Campers may check in earlier on day of reservation if site is available.
- CHECK-OUT TIME is by 3 PM. Campers and their guests are required to leave the campground at check out time.
 An additional night's camping fee may be charged for late departures.
- VISITORS must depart the campground by 10 PM or earlier, if the visited camper checks out prior to this time. Visitors are subject to same regulations as registered campers.
- GATE is locked from 10:30 PM to 7 AM. Emergency exits only during these hours. For emergency exit, see on duty Park Attendant at their campsite.
- 8. COURTESY PASSES are restricted to the hours of 7 AM until dark. Passes will not be issued when the park is over 75% occupied due to safety considerations.
- CAMPING LIMIT is 14 consecutive days or 14 nonconsecutive days in any 30-day period at all Corps of Engineers-operated campgrounds on the Allatoona Lake Project.
- 10. QUIET HOURS are in effect from 10 PM to 6 AM daily. Unreasonably loud noise is prohibited at any time.
- PASSES MUST BE DISPLAYED from rearview mirror or dash of all vehicles.
- 12. FIREWORKS, FIREARMS, EXPLOSIVES, and PROJECTILE-FIRING DEVICES are prohibited.
- 13. CAMPFIRES must be confined to fireplaces or grills. Do not leave fires unattended. Extinguish all fires upon departure from campsite. Only dead wood on the ground may be collected for firewood.
- DESIGNATED SWIMMING AREAS are not supervised. Swim at your own risk. Swimming at launching ramps and courtesy docks is prohibited.
- TREES in the park are protected. Hang lanterns on metal hangers at the campsite. Do not nail, saw, or cut trees.
- PETS MAXIMUM THREE (3) PETS PER CAMPSITE (NO EXCEPTIONS) Wild, exotic, vicious and/or

- aggressive pets and livestock are not permitted in the campground. Excessive barking or disturbance by pets is prohibited at any times. All pets must be penned, caged or restrained on a leash no longer than six (6) feet. Invisible fences or shock collars are not sufficient. Pet owners must dispose of all pet waste in dumpsters. Pets are not allowed in restrooms, on playgrounds, or on beaches. DO NOT LEAVE PETS UNATTENDED INSIDE OR OUTSIDE THE CAMPER AND/OR TENT.
- 17. SINKS in restrooms and laundry rooms are not to be used for washing pets or dishes, cleaning fish, etc.
- 18. GRAY/WASTE WATER must be caught in holding tank or other receptacle and deposited at the dump station. Washing vehicles, camping equipment, or anything that produces gray water to be discharged on or around the campsite is prohibited.
- 19. FEEDING GEESE AND OTHER WILDLIFE is prohibited due to health and environmental concerns.
- 20. ALL GARBAGE MUST BE PLACED IN THE DUMPSTERS which are located at shower wash houses and dump stations. Do not deposit garbage in firerings or grills. Campsite must be kept clean during occupancy and cleaned upon departure. Do not leave garbage bags on the site.
- 21. VEHICLES must be street legal, operated by a licensed driver and parked on paved surfaces. No golf carts/ scooters/mini-bikes, etc. No riding on the exterior of vehicles. No joy riding.
- 22. Golden Age/Golden Access Passports and Interagency Senior/Access Pass holder is the only individual authorized to use a discount pass when registering and paying user fees. The holder must be a member of the camping party, must occupy the campsite overnight and will be required to show photo identification and passport or pass. Passports/passes may not be applied to multiple sites at the same time or applied to double sites.
- Any act or conduct which interferes with, impedes or disrupts another person's use of the project (boisterous, rowdy or disorderly) is prohibited.
- Failure to abide by these park regulations and restrictions may result in legal action, expulsion, and/or forfeiture of fees paid.
- 25. The person registered for a campsite shall be presumed to be responsible for any violation of rules unless proven otherwise.
- 26. Interference with any Park Ranger, government employee, volunteer or contractor in the conduct of their official duty is prohibited. Individuals may be required to furnish proper identification to Park Rangers.
