

## **RULES FOR BLACK WARRIOR AND TOMBIGBEE LAKES SPECIAL OPPORTUNITY DEER HUNT - DECEMBER 2019**

Welcome to the first BWT Lakes Special Opportunity Deer Hunt. This hunt is designated for permanently disabled individuals. Applications will be sent to [bwthelp@usace.army.mil](mailto:bwthelp@usace.army.mil) or mailed to one of the addresses listed on the applications page. Deadline for application is Oct. 31, 2019, 11:59 p.m. Applications will be chosen by a random drawing and individuals selected will be notified no later than Nov. 5, 2019. The Special Opportunity Deer Hunt is an archery hunt only (compound, traditional, or crossbows are allowed). All hunting equipment, including stands/blinds, must be provided by the individual. An assistant for each individual is advised, but not a requirement unless the hunter is 16 years old or younger. In order for the event to be fair and safe for everyone involved, the following rules are necessary.

### **General Rules**

1. All state and federal hunting laws and regulations, including BWT Lakes regulations, apply during this hunt and will be enforced. Anyone violating the regulations will be dismissed from the hunt and future hunts.
2. A meeting will be held on Nov 15, 2019 at 2:30 p.m. at Demopolis or Holt Resource Management Offices (addresses listed below) to cover regulations and draw for hunting areas. Arrangements must be made and approved if you are unable to attend. Archery equipment must be brought at this time in order to complete a proficiency test. All hunters must be able to hit a 10 inch circle at 20 yards with three out of five arrows.
3. Hunting will be strictly limited to designated areas and times. Hunting hours for this hunt are Saturday 12:00 pm 6:00 p.m. and Sunday 6:00 a.m. to 12:00 p.m. No equipment may be setup before 12:00 p.m. Saturday or left after 12:00 p.m. Sunday.
4. A limit of two deer may be harvested during the hunt, of which only one may be a buck. Bucks must have three points on one side.
5. Harvested deer will be taken to the designated check-in area to be examined, weighed, and aged. Field dressing is permitted. All other processing is to be done off Corps property.
6. Hunters must check in/out with a ranger or volunteer when going into the field and when returning. Quiet hours for the hunt are 2:00 p.m. till 5:30 p.m. and 6:30 to 9:30am.
7. Weapons must meet all the requirements set by the Alabama Department of Natural Resources. The use of compound bows and crossbows are permitted; however, safety is the top priority. Hunters will not shoot if there is any doubt about the safety of the shot, and no shots will be taken near or in the direction of fellow hunters.
8. Assistants, whether adults or children, will not be permitted to use the weapon.
9. Hunters younger than 16 are required to have an adult assistant (21 years of age or older).
