II. FINDINGS

- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: A desktop review was performed for the approximately 20 acre undeveloped area of the larger 60 acre property and revealed that the project will occur within a highly disturbed area that has been historically used for dredge material disposal. The subject parcel is surrounded by railroad tracks on the western half, and by industrial facilities on the eastern half. On-site soils are shown to be comprised of at least 85% Anthroportic Udorthents; which are characterized by human-transported materials over loamy marine deposits. No hydrology appears to be present within the review area; and dominant vegetation includes mostly FAC and UPL species such as cogon grass, Ilex vomitoria, Pinus palustris, Ligustrum spp., and Myrica cerifera.
