328.3(a), "Waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of CWA (other than cooling ponds as defined in 40 CFR 123.11(m) which also meet the criteria of this definition) are not waters of the United States." Therefore, Basins 025, 028, 047, and 047B are not waters of the U.S. Location and size info: Basin 025 33.370997, -87.088477, 9.34 acres; Basin 028 33.374348, -87.081732, 0.73 acre; Basin 047 33.379652, -87.067441, 5.87 acres; Basin 047B 33.374504, -87.068639, 3.28 acres.

The features identified as D1, D2 and D3 are ditches that were created in uplands, drain only uplands and have less than a relatively permanent flow of water. The 12/2/2008 Memo titled "Clean Water Act Jurisdiction Following the U.S. Supreme Court's Decision in Rapanos v. United States & Carabell v. United States" indicates ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are generally not jurisdictional. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
