Explain: **The review area for this AJD form only includes the areas identified as OW-1, OW-2, OW-3, S-6, S-7, S-8, Basin 047C, and W-2. W-2 is a 0.71-acre wetland located at 33.369569, -87.073020 and was likely formed in uplands incidental to pre-SMCRA mining at the site. This wetland is geographically isolated from an RPW or TNW. The closest RPW is an unnamed tributary to Valley Creek located approximately 2,100 feet northeast of the wetland. W-2**

does not support a link to interstate or foreign commerce. W-2 is not known to support interstate or foreign commerce. It is not known to be used by interstate or foreign travelers for recreation or other purposes. W-2 does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, or used for industrial purposes by industries in interstate commerce. For all of these reasons, W-2 does not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a) and is not jurisdictional under the Clean Water Act.

OW-1, OW-2, and OW-3 are isolated pits adjacent to a highwall that were created in uplands during surface coal mining activities at the site. Pursuant to the preamble to the final 33 CFR Part 328 (51 FR 41206 November 13, 1986) these types of waters are not considered to be waters of the US. See preamble 328.3 Definitions (e), which states the Corps generally does not consider the following water to be waters of the U.S. : "Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States (see 33 CFR 328.3(a))." OW-1, OW-2, and OW-3 do not support a link to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce. For all of these reasons, these features do not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a). OW-1 is 0.51 acre located at 33.369404, -87.073952. OW-2 is 0.86 acre located at 33.370974, -87.071612. OW-3 is 4.2 acre located at 33.371352, -87.070710.

S-6, S-7, and S-8 are geographically isolated streams because they flow into non-jurisdictional, isolated mining pits discussed previously (OW-1, OW-2, and OW-3); therefore, they are not tributaries to a TNW. These waterbodies do not support a link to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, or used for industrial purposes by industries in interstate commerce. For all of these reasons, these features do not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a). S-6 is ephemeral, 237 lf in length, and located at 33.367739, -87.075808, S-7 is intermittent, 185 lf in length and located at 33.370023, -87.072784. S-8 is intermittent, 532 lf in length and located at 33.370466, -87.069490.

Basin 047C was created as a permitted NPDES sediment basin designed to meet Clean Water Act requirements. Pursuant to 33 CFR Part 328 (51 FR 41206 November 13, 1986) these types of waters are not considered to be waters of the U. S. See 328.3(a), "Waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of CWA (other than cooling ponds as defined in 40 CFR 123.11(m) which also meet the criteria of this definition) are not waters of the United States." Therefore, Basin 047C is not a water of the U.S. Basin 047C is 0.97 acre in size located at 33.368152, -87.075154.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
