Review area wetland (East Grady) is an isolated, depressional wetland bounded on the north and south by agricultural lands, on the west by the St. Augustine residential subdivision, and on the east by County Road 54 West. A roadside ditch on the west side of CR-54 and directly adjoining the review area wetland was found to contain hydric soils in the vicinity of the review wetland and is surficially connected to the review area wetland. However, hydric soils drop out as the ditch continues to the south. Based on LIDAR data and onsite observations, the roadside ditch drains to the south for approximately 3,400 feet, then east through a small concrete culvert under CR-54, then east-southeast through a series of vegetated uplands and/or upland swales for approximately 5,800 feet before entering Fish River just north of its crossing under the County Road 64 bridge near Dixon Lane. The total linear distance between the review area wetland and the nearest TNW is approximately 1.74 linear miles to Fish River to the southeast. Any surface water connection between the subject wetland/pond and the receiving TNW is expected to be infrequent and tenuous. Therefore, the subject wetlands were determined to be isolated and do not have a significant nexus with a TNW

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Across CR-54 to the east, drainage appears to be inconsistent uplands and/or upland swales southeast towards Fish River. Accordingly, there is insufficient evidence of surface connection between the review area wetland to jurisdictional waters of the U.S. to meet the Significant Nexus standard.**
