- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: [Area C] Based on review of the agent's delineation report (McGehee Engineering Corp) and available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the 1-acre area that would be impacted by the proposed power bore hole in Tuscaloosa County is a dry land area consisting primarily of undeveloped hardwoods. Desktop resources evaluated also indicate the JD review area lacks perennial or intermittent tributaries or associated wetlands.
