C. Additional comments to support AJD: The forested drainageway and ditch to the south of the property is located entirely in mapped hydric soils, Atmore Loam, per NRCS. The subject property forested wetlands connect to the Forested drainageway south of the property through a road barrier/culvert, which then connects to the Cypress Creek forested drainageway, a perennial (a)(2) tributary, which then flows into the Tchoutacabouffa River, an (a)(1) tributary. The subject property ditch receives roadside drainage from the north side of the property as well as sheetflow run-off from the properties to the north.
