review area; however, it was determined these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements. The potential wetland areas did not meet all three parameters required to be classified as jurisdictional wetlands.

Points sampled within the provided Wetland Delineation (performed by Northstar Engineering Services) were analyzed by the RD-A Project Manager due to their proximity to the new proposed work footprints. Upland sample points did not contain all three wetland indicators. Point 4 falls along the upland southern boundary of the stream and wetlands found on the west property (4276 Fortner Street) of the Dothan trails project. Point 4 in the provided wetland determination data form does not indicate wetland hydrology nor do hydric soils appear to be present even though hydrophytic vegetation is dominant at this point. Indicators of hydric soil and wetland hydrology must be present in order for this point to qualify as a wetland point--however, it does not. Additionally, Point 6 on the wetland determination data form was sampled on the eastern property of the Dothan trails project (3636 Fortner Street). Point 6 data supports the lack of wetland hydrology and lack of hydric soils even though hydrophytic vegetation (such as Magnolia virginiana, Quercus nigra, and Osmunda cinnamomea) does appear to be dominant. Indicators of hydric soil and wetland hydrology must be present for this point to qualify as a wetland point--however, it does not. See section III.F for additional information.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions per formed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are notlimited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
