  - The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and delineation data forms completed by McGehee, the JD review area consists of upland/non-wetland, dry lands areas. Aerial photography shows the 3-acre area E that would be impacted by the proposed R-50 mine revision in Jefferson County is a dry land area consisting primarily of hardwoods and developed roadway. Desktop resources evaluated also indicate the JD review area lacks perennial or intermittent tributaries or associated wetlands.
