Soils in review area wetlands were historically mapped as Grady Pond, and the boundaries of the feature are apparent in aerial imagery dating back to 1938. Aerials between 1952 and 1967**

show the Grady pond was excavated by the landowner for use as a livestock or agricultural pond. Satellite and onsite observations indicate the excavated soils were side-cast around the perimeter of the Grady feature. Currently, the pond feature is mostly open water with some emergent/scrub wetlands present near the northwest margins of the pond. The property is under development as a residential neighborhood, and stormwater is directed via subterranean concrete pipes into the subject wetland/pond from an existing basin to the north. A stormwater riser inlet has been installed in the subject wetland/pond near the southeast side, which captures and directs stormwater via subterranean storm pipe to a third stormwater pond (Pond 3) approximately 600 ft. to the southeast. Prior to connection between the subject wetland/pond and the recently excavated Pond 3 to the southeast, water was discharged from the subject wetland/pond via sheet flow only. Pond 3 is expected to periodically discharge surface water from the subject wetland/pond via berm overflow to an adjacent forested wetland drain which periodically carries rainwater to the south for approximately 1.75 miles before entering Cowpen Creek. The wetland drain near Pond 3 extends south 2,000 ft. to Sedgefield Ave, then south-southwest 3,000 ft., draining variably as sheet flow and/or grassed swales until reaching Cowpen Creek. The drainageway does not exhibit consistent bed/bank features and soils are mapped inconsistently between hydric (Bibb) and non-hydric (Iuka) series. The linear distance between Pond 3 to the nearest TNW is approximately 6 linear miles to Fish River to the southeast. Any surface water connection between the subject wetland/pond and the receiving TNW is expected to be infrequent and tenuous, and would be primarily dependent upon 1) The holding capacity of the larger upgradient stormwater basin; 2) The infrequent capacity-driven discharges between the subject wetland/pond and downgradient Pond 3 to the southeast; and, 3) The subsequent infrequency of capacity-driven discharges from Pond 3 to the nearby wetland drain to the southeast. Therefore, the subject wetlands were determined to be isolated and do not have a significant nexus with a TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
