Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Approximately 0.9 acre isolated grady pond** 

A detailed wetland delineation found that this wetland is completely surrounded by existing commercially developed tracts of land and undeveloped land areas consisting of high chroma upland soils. The land surrounding the isolated wetland has an extensive history of land grading and human-induced drainage manipulation dating back to 1955 and earlier in order to facilitate farming activity based on review of historic aerial photography. A shallow man-made agriculture-related swale that runs south from the Grady pond to a drainage ditch that connects to an unnamed tributary to the Magnolia River appears to have been created in this location around 1966; however, the swale has no defined bed and bank or hydric soils nor any other observable evidence [such as flow damaged vegetation] that it provides a frequent or sustained surface hydrologic connection between the Grady pond wetland and other wetlands or streams that connect to navigable waters. This wetland is also located outside of any designated flood plain. Based on field observations this wetland was determined to be an isolated wetland feature with no demonstrable surface water connection or nexus to downstream Waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This wetland is a distinctly rectangular feature which suggests it is a man-made or manipulated feature. A detailed wetland delineation found that this wetland is completely surrounded by undeveloped land areas consisting predominantly of high chroma upland soils. The land surrounding the isolated wetland has an extensive history of land grading and human-induced drainage manipulation dating back to 1955 and earlier in order to facilitate farming activity based on review of historic aerial photography. Although the wetland is located within approximately 60 feet of a man-made ditch that drains to a tributary to Magnolia River, there is no surface hydrologic connection between this wetland and the ditch or other wetlands or streams that connect to navigable waters. This wetland is located outside of any designated flood plain. Based on field observations this wetland was determined to be an isolated wetland feature with no surface water connection to downstream Waters of the U.S.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
