C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Because of questions raised by USGS topographic mapping, as to whether the ditch that will be crossed by a new access drive to the pump station is possibly an old channelization of a natural ephemeral or intermittent tributary feature or a ditch constructed in uplands and draining only uplands, the history of the feature was investigated further. Based primarily on information provided by the applicant/agent regarding the use and history of the ditch feature, as well as review of web soil survey mapping, and historic aerial photography, it has been determined that the ditch is a manmade feature maintained by Blount County for road drainage that was constructed solely in uplands and drains only uplands, and therefore is a non-jurisdictional drainage feature. It appears the natural tributary that may have existed historically in this general area was located where a pond currently exists to the west of the proposed pump station site. The approximately 0.10 acre of land that would be disturbed to construct the pump station facility and connect the pump station to existing water lines is a non-jurisdictional dry land/upland area.
