The Corps previously issued AJDs for the site in 2006 and again in 2011 which determined that no wetlands occur on the property. Clearing and filling activities were conducted following issuance of the first AJD in 2006.

  - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Review area is approximately 4.85 acres. A majority of the parcel consists of non-wetlands or dry lands, with the exception of the GIWW (a TNW and Navigable WOUS) which abuts the north shoreline of the property and a small 0.08-acre wetland ditch which runs south to north along the east side of the parcel, as noted above in Sections IIA and IIB. File history indicates the parcel was previously used for dredged material disposal during construction and maintenance of the GIWW. As noted above in Section IC, the parcel was previously determined by the Corps to be non-wetland uplands in 2006 and again in 2011. Sandy fill material was placed on the parcel in 2006 following issuance of the first AJD. A data form was provided in 2019 for the central area of the parcel, which found no hydrology or hydric soil indicators present, with a positive indicator for hydrophytic vegetation. The 2019 data were collected during the wet season. Data form noted that saturation was observed in surficial layers at 9 inches; however, this indicator must be associated with an existing water table immediately below the saturated zone water table was documented at 24 inches deep. Data form noted that a thin soil layer at 3-5 inches contained 2% redox concentrations, but was below the thickness threshold of 4 inches needed to meet hydric soil indicator S5 Sandy Redox. Soils in the review area are mapped as Made Land on the western portion and Scranton series (non-hydric) within the central and eastern portions of the site. A previous field visit by USACE on January 11, 2019 supports these findings.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
