approximate 103 linear foot ephemeral channel that flows into Pond 1. C-1 is located approximately 1,048 south (bearing 198.910°) of Lily Street (Lat. 33.61276°, Long. -86.50082°). Channel 2 (C-2) is an approximate 462 linear foot channel with intermittent flow located approximately 1,331 feet south/southwest (bearing 222.81°) of Lily Street (Lat. 33.6134°, Long. -86.50278°). Channel 3 (C-3) is an approximate 658 linear foot channel with ephemeral flow located approximately 855 linear feet south/southwest (bearing 235.08°) of Lily Street (Lat. 33.61396°, Long. -86.50233°). Channel 4 (C-4) is an approximate 968 linear foot channel with intermittent flow located approximately 360 linear feet southwest (bearing 254.01°) of Lily Street (Lat. 33.61536°, Long. -86.50173°). Channel 5 (C-5) is an approximate 42 foot channel with ephemeral flow located approximately 360 linear feet west (bearing 257.33°) of Lily Street (Lat. 33.61544°, Long. -86.50089°). Channel 6 (C-6) is an approximate 161 foot channel with intermittent flow located approximately 445 linear feet west (bearing 278.34°) of Lily Street (Lat. 33.61576°, Long. -86.50122°).

P-1, P-2, C-1, C-2, C-3, C-4, C-5, and C-6 are all features that were created during pre-SMCRA mining activities at the site. There is no downstream connection from these areas to waters of the U.S. Pursuant to the preamble to the Final 33 CFR Part 328 (51 FR 41206 November 13, 1986) these types of waters are not considered to be waters of the US. See preamble 328.3 Definitions (e), which states the Corps generally does not consider the following water to be waters of the U.S. : "Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States (see 33 CFR 328.3(a))." These waterbodies do not support a link to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
