Explain: **Review Area is approximately 11.32 acres and contains a 3.4-acre isolated, non-jurisdictional wetland located on the east side of the subject parcel adjacent to Springhill Memorial Drive South. Soils in the review area were**

historically mapped as Smithton-Urban Land Complex (hydric, poorly drained). The area has been extremely modified as a result of urban development associated with construction of the Springhill Medical Center in 1975. Historic records are limited, but the review area wetland appears to have been part of a larger wetland complex identified on early USGS topographic maps as Wragg Swamp. Between the 1950s and 1990s, a system of drainage ditches were constructed through Wragg Swamp in areas south and east of Spring Hill College (one mile to the northwest). The eastern portion of this ditch system (now mapped as Eslava Creek on USGS Topos, but locally referred to as Wragg Swamp Canal or Montlimar Creek) flows south along the west side of the subject parcel. Montlimar Creek appears to be a perennial RPW which drains south to Dog River which is a TNW. The side-cast material from original construction of the ditch formed an approximately 7-8 ft. high berm between the review area wetland and Montlimar creek to the west. The berm and adjacent uplands form an approximately 300-foot-wide barrier between the review area wetland and the top bank of Montlimar Creek. The review area wetland is bounded on the north by a parking area, and on the south and east by Springhill Memorial Drive South. During a field review on November 27, 2018, the USACE, Mobile District did not document any breaches or culverts through the berm that would provide direct surface connection to Montlimar Creek to the west. The USACE noted that infrequent overflow is possible from the review area wetland eastward into the streetside curb along Springhill Memorial Drive South. The streetside drainage flows south approximately 100 feet to a subterranean stormwater inlet, which flows approximately 1,800 feet southeast to an open ditch adjacent to I-65 and Airport Blvd, then east via ditches and stormwater pipes for 2,800 feet to Eslava Creek, then 3.3 miles east and south before reaching Dog River. As such, there is no evidence of any appreciable surface water connection between the review area wetland and the receiving TNW. Therefore, the subject wetland was determined to be isolated and does not have a significant nexus with the downstream TNW.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
