review area wetlands were historically mapped as Grady. Review area wetland (14<sup>th</sup> St. Grady) is an approximately 30-acre isolated, depressionnal wetland bounded on the north, east, and south by residential neighborhoods, and on the west by the Clarke Avenue road easement, and further west by State Highway 59. The review area wetland is positioned within a well-defined grady pond depression within a flat landform on an elevated ridge. Available LIDAR contour data show the outer perimeter of the wetland area is at elevation 272' MSL while the center of the wetland area is at 267' MSL. Soils around the outer perimeter of the review area wetland are in the Irvington series, which are non-hydric soils, typically positioned in uplands or interstream divides. During the field review on November 27, 2018, the USACE, Mobile District conducted a pedestrian survey of the entire wetland perimeter and did not observe any culverts, swales, or ditches that provide outflow from the subject wetland to downgradient waters. The USACE documented a single culvert on the north side of the wetland area at the intersection of Armstrong Avenue and 14<sup>th</sup> Street, which conveys stormwater into the subject wetland from the surrounding neighborhoods via roadside ditches. The elevation/grade of the ditch was confirmed via LIDAR contour data. During field review, the USACE documented a ditch to the south of the wetland area that conveys storm drainage from 11<sup>th</sup> Street to the east towards the Clarke Ave easement to the west. The ditch is separated from the 30-acre review area wetland by approximately 400 ft. of uplands which are approximately 3-5 ft. higher in elevation than the review area wetland to the north and exhibit no signs of surface connection, either discrete or via sheet flow. FEMA flood maps indicate an isolated area on the south side of the wetland which is designated Zone A; however, the designated area does not intersect the ditch and there is no observable evidence of flooding of uplands on the south side of the review wetland that would indicate any frequent or appreciable discharge of floodwaters to the drainage ditch to the south. The nearest TNW is Bay Minette Creek, which is located 13.5 linear miles from the review wetland. The area surrounding the 30-acre review wetland drains approximately 3,000 linear feet south via roadside ditches along State Highway 59, then approximately 8,200 linear feet southwest via a channelized UT to Whitehouse Creek, then drains the remaining 11.5 linear miles south/southwest via Whitehouse Creek into Bay Minette Creek. There is no evidence of a surface water connection between the review wetland and the receiving TNW. Therefore, the subject wetland was determined to be isolated and does not have a significant nexus with a TNW.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
