at N 33.514941, W 86.750817. This wetland is geographically isolated with no hydrologic connection to any downstream waters. There is an outfall riser pipe in the basin; however, this pipe is approximately 8-10 feet tall and the water never rises to the top level of the structure. In fact, the basin does not hold water, which is why it has developed into a wetland over the years. Downgradient of this wetland is Medical Park Drive South and parking lots and medical offices, followed by Montclair Road. The closest water is Owens Pond, nearly 3,000 feet to the southeast of the wetland. Owens Pond appears to be part of the headwater system of Shades Creek.

The wetland has no nexus to interstate or foreign commerce. It is not known to be used by interstate or foreign travelers for recreation or other purposes. It does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and is not known to be used for industrial purposes by industries in interstate commerce.

For these reasons, this wetland is not a water of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
