Explain: **Review Area is approximately 7 acres and contains a 2.53-acre isolated, non-jurisdictional wetland located on the west side of the subject parcel, adjacent to County Road 13. Soils in review area wetlands were historically mapped**

as Grady (hydric, poorly drained) surrounded by Greenville and Red Bay (non-hydric, well drained), and the boundaries of the wetland feature are apparent in aerial imagery dating back to 1952. The subject parcel has been used for sand and gravel mining since the early 1990s. A series of mining pit lakes are located east of the review area, and these lakes appear to have some limited interconnectivity with each other and ultimately with Cowpen Creek to the north. Cowpen Creek is an RPW which flows approximately 4.8 miles east before its confluence with Fish River. During a site visit on January 28, 2020, the USACE documented that stormwater flows into the review area wetlands via roadside ditches along CR-13. The wetlands drain north via narrow, incised ditch into a highly disturbed upland area on the northwest side of the parcel. Discharge from the review area wetland appears to occur only in response to recent storm events, and there are indications that flow is dispersed and percolates through the soil in this area. USACE did not observe any evidence of a continuous surface connection between the wetland and Cowpen Creek 1,000 feet to the north nor the mining lakes 300 feet to the east. Review area wetlands are not located within a floodplain. Given the disturbed nature of the surrounding uplands and separation from downstream waters, ecological functions provided by the review area wetlands are expected to be mostly confined to the site. Therefore, the subject wetlands were determined to be isolated and do not have a significant nexus with a TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
