depressional wetland located within the south-central portion of the subject parcel. The subject parcel was extensively modified between the 1930s to 1990s, during which time a series of ditches, drainageways, and roads were constructed. Isolated Wetland 2 is isolated by a berm along the north, south, and west sides, and is separated by several hundred feet of uplands on the east side. During the field review on August 22, 2019, the USACE, Mobile District conducted a pedestrian survey of the wetland perimeter and did not observe any culverts, swales, or ditches that provide definitive surface water connection to downgradient waters. The nearest jurisdictional water is Wetland B approximately 100 feet to the north at the closest point, and is physically separated from Isolated Wetland 2 by a perimeter berm. A small erosional rill feature was documented in this area; however, there was no evidence of regular, meaningful surface connection between the two features. Threemile Creek is located approximately 970 feet south of Isolated Wetland 2. Threemile Creek is recorded as a TNW approximately 2 miles east of the subject parcel starting at River Mile 4 and continuing east to its confluence with Mobile River. There is no evidence of any appreciable surface water connection between Isolated Wetland 2 and the receiving TNW. Therefore, the subject wetland was determined to be isolated and does not have a significant nexus with the downstream TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
