- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetlands W-E and W-F appear to have been created incidental to land management and transportation activities within the review area. W-E consists of a 0.699 acre wetland located in a shallow depression. The depression area was created as a result of historic silviculture and mineral extraction activities. W-E drains to the south and quickly becomes dry land/upland after leaving the review area. The closest potentially jurisdictional tributary (Mortar Creek) is 498 linear feet (lf) NE (Heading 32.2°). Similarly, W-F, a 0.934 acre wetland, is located within a closed depression; it is bounded to the east by a rail line and to the west by an existing county road. The nearest potentially jurisdictional tributary (Mortar Creek) is 1,582 linear feet (lf) NE (Heading 69.5°). Both W-E and W-F are situated outside of the 500-year (0.2% return interval) floodplain and both wetlands are geographically isolated from any tributaries. These wetlands and waters do not support a link to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce. For these reasons W-E and W-F are not jurisdictional waters of the U.S.**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
