**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, and historic aerial photography, the project area consists of upland/non-wetland, dry lands. Aerial photography shows that no streams, wetlands, or other WOUS are present within the sewer force main installation review area along Summerville Road (Lee County Rd 248). The review area is located in a dry land area. USGS topography and HUC mapping show that the review area runs along a natural upland ridge line that separates two watershed areas.
