(0.08 acre) located at 33.820579, -87.375478, P8 (0.04 acre) located at 33.820134, -87.377661, P9 (0.13 acre) 33.820134, -87.377661, and P12 (0.04 acre) located at 33.824209, -87.385214. These features were created in uplands during pre-SMCRA surface coal mining at the site. There is no downstream connection from these areas to waters of the U.S. Pursuant to the preamble to 33 CFR Part 328 (51 FR 41206 November 13, 1986), these types of waters are not considered to be waters of the U.S. See preamble to 328.3 Definitions (e), which states the Corps generally does not consider the following to be waters of the U.S. : "Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States (33 CFR 328.3(a))." These waterbodies do not support a link to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce. For all of these reasons, these features do not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a). D3 is a ditch dug in uplands with ephemeral flow and drains only uplands; therefore, it does not meet the definition of waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
